I. GENERAL COURSE INFORMATION:

- A. Course Description: This course is an introduction to the automobile industry, including automotive history, safety practices, shop equipment and tools, vehicle subsystems, service publications, fasteners, professional responsibilities, and automobile maintenance.
- B. Course Learning Outcomes: The student will explain the history of the automobile and career possibilities of the automobile industry, explain safe, professional, and responsible work practices, identify and explain proper use of shop tools and equipment, explain functions of vehicle subsystems and explain the use of service publications, identify the various automobile fasteners used in the industry; and explain automotive maintenance.
- C. Course Competencies: Upon completion of this course the student must demonstrate the following competencies:
  - 1. Practice shop safety throughout the automotive industry, discuss and practice all requirements of a professional technician.
  - 2. Select and use automotive tools efficiently.
  - 3. Identify and use a vehicle's identification number effectively.
  - 4. Fill out and use a repair order efficiently.
  - 5. Use parts/service publications effectively.
  - 6. Use labor/time guides effectively.
  - 7. Use the AllDATA systems effectively.
  - 8. Thoroughly understand different lubricants used in the automotive industry
  - 9. Thoroughly understand service procedures for basic vehicle subsystems
  - 10. Thoroughly understand basic electrical diagnostics and DVOM use.
  - 11. Demonstrate proper use of manuals and computer equipment to retrieve information on proper repair procedures to properly complete a task.

## II. SPECIFIC COURSE/INSTRUCTOR REQUIREMENTS:

- A. Textbook and Other Materials:  
Textbook and Other Materials: Today’s Technician \ Basic Automotive Service and Systems 3<sup>rd</sup> Edition by Clifton E. Owen. Students are required to possess a basic tool set for the program by the 12<sup>th</sup> class day.
- B. Attendance Policy: Whenever absences become excessive and, in the instructor's opinion, minimum course objectives cannot be met due to absences, the student should be withdrawn from the course. In addition, an instructor is required to notify the Office of Student Services when the student has missed every class day during any 14 consecutive calendar-day period, excluding holidays.

When an unavoidable reason for class absence arises, such as illness, an official trip authorized by the college or an official activity, the instructor may permit the student to make up work missed. It is the student’s responsibility to complete work missed within a reasonable period of time as determined by the instructor.

Students are officially enrolled in all courses in which they pay tuition and fees at the time of registration. Should a student, for any reason, delay in reporting to class after official enrollment, absences will be attributed to the student from the first meeting of the class.

A student who does not attend a class and does not officially withdraw from that course by the 12<sup>th</sup> class day in a regular semester or by the 4<sup>th</sup> class day in a summer session should be administratively withdrawn from that course and receive a grade of “X” or “F” as determined by the instructor. Instructors are responsible by clearly stating their administrative drop policy in the course syllabus, and it is the student’s responsibility to be aware of that policy.

**Regular attendance is required.** Roll will be checked at the beginning of each class and after lunch. Absences may affect the final grade as follows:

- fourth absence (4<sup>th</sup>), final grade may be lowered 5 points
- fifth absence (5<sup>th</sup>), final grade may be lowered an additional 5 points (20 points from initial grade).
- sixth absence (6<sup>th</sup>), final grade may be lowered an additional 5 points (30 points from initial grade).

If you miss 30 minutes or more, you will be considered absent for that day. Three (3) tardies are considered to equal 1 absence. On the 6<sup>th</sup> absence, you may be automatically dropped from all automotive courses in which you are enrolled for this semester. If the excessive absence occurs after the official drop date at the

end of the semester, a grade of "F" will be issued. Tardies and absences will be applied to all courses.

- C. Assignment Policy: Class assignments and/or homework may be given at the instructor's discretion. Homework and other assignments are due on time. Late work will not be accepted. If you are late for an exam, you will not be allowed to take the exam and will receive a grade of zero on that exam. Students are expected to complete all assignments. When assigned to a lab competency, the student is expected to stay with the project until completion.
- D. Grading Policy/Procedure and/or methods of evaluation: There are three categories taken into consideration when computing the final semester grades. The percentages below will be calculated based on points given for completion of the following objectives:
  - 1. Attitude objectives: 20 %
  - 2. Skills objectives: 50%
  - 3. Knowledge objectives: 30%

There are four levels of attainable grades in the Automotive Service Technology program. This grading policy follows industry standards used in ASE certification testing. The levels are:

A (90 and above)

B (80 to 89)

C (70 to 79)

F (69 and below)

- E. Special Requirements: The student must pass a series of comprehensive exit exams related to the main competencies covered in the automotive courses. The exams shall be administered during the last semester of the program.
- F. Behavior: The student is expected to follow all of the rules and regulations of the program, provided to you the first week of class and posted in the classroom and lab area. Students who are deemed by their instructor to be disruptive, disrespectful, and/or otherwise detrimental to the class may be dropped from all automotive courses in which you are enrolled for the semester.

### **HAZARDOUS MATERIALS**

Students will come in contact with chemicals and other materials, which come under the "HAZARDOUS MATERIALS" classification as defined by Title 83, Article 5182b of the Hazard Communication Act. Material Safety Data Sheets (MSDS) information will be posted outside of office number 1. Warning signs are posted throughout the Auto/Diesel building and all appropriate personal protective equipment will be provided, which the student must use. Safety information will be given and demonstrated in class before safety quizzes and test.

### III. COURSE OUTLINE/CONTENT

Upon completion of these units, the student will be able to:

1. **Shop Safety**
  - a. raise and lower a vehicle safely, using the shop's hoists.
  - b. practice the safe use of other shop equipment such as safety glasses, compressed air, floor jacks, jack stands, electric drills, drop lights, creepers, fender covers and fire extinguishers.
  - c. practice the techniques of lifting heavy objects.
  - d. have an awareness of MSDS and other OSHA regulations.
2. **Read all handouts concerning safety.**
  - a. Identify and discuss the importance of cleanliness, both personal and occupational.
  - b. practice responsible co-worker relations.
  - c. practice effective customer relations.
  - d. understand and practice the concept of doing the job right the first time.
  - e. write a professional resume.
3. **Vehicle Identification Numbers, Service Manuals, Vehicle Lubricants and Maintenance Schedules**
  - a. understand the importance of a vehicle's VIN
  - b. use a VIN to describe body styles, engine sizes, and year models.
  - c. use a VIN to describe manufacturing plants, restraint systems, and vehicle makes.
  - d. have a basic understanding of manufacturer option codes.
  - e. thoroughly understand the difference between engine oils, transmission fluids, other lubricants and their correct applications.
  - f. read and understand vehicle maintenance schedules
  - g. use service manuals quickly and accurately
4. **Repair Orders and Labor/Time guides**
  - a. use the ALL DATA system effectively.
  - b. understand the purpose of repair orders, including disclaimers and record keeping.
  - c. correctly fill out a repair order, including VIN's, customer information, parts, and the 3 C's.
  - d. use a repair order from a technician's viewpoint.
  - e. functionally use a labor/time guide, including reasonable fees charged for repairs.
5. **Automotive Tools/Precision Tools and Their Use**
  - a. have the opportunity to explore tool needs, selection, and pricing/purchasing with representatives from the industry.
  - b. select and use torque wrenches correctly.
  - c. select and use impact wrenches, air ratchets, and air hammers correctly.
  - d. use tape measures, rulers, and calipers correctly
  - e. have a basic understanding of bolt sizes and strength markings
  - f. distinguish between metric and standard size bolts

- g. use a tap and die set correctly
  - h. use extractors and removers correctly
  - i. Use feeler gauges, micrometers, and dial indicators correctly.
6. **Automotive Electrical Service**
- a. Understand basic electrical diagnosis
  - b. Understand DVOM (Digital Volt/Ohm Meter) uses and diagnostic procedures.
