2. Meet SPC Admission criteria and be TSIA compliant. Check with Admission office for more information on TSIA2.

3. Have a GPA or 2.0 or higher. The program cannot take candidates who do not have a 2.0 GPA.

4. Take and pass the program entrance test, the *Test of Essential Academic Skills (TEAS*). Please visit the Testing Center Website for information on testing:

We recommend that you use a PC for registration and not your cell phone. You must pay a <u>non-refundable \$75 test fee</u> at time of registration for each TEAS. Scores are good for one year. TEAS testing is limited to four (4) times per application period. We recommend testing early so that you have an opportunity to retest.

## 5. Complete the application found online and attach your passing TEAS scores to the completed application. <u>YOU MUST</u> <u>TURN IN YOUR APPLICATION and all required documents (Application, TEAS scores and Transcripts) BY THE DEADLINE.</u> *The program cannot accept incomplete packets—please be sure you have all required documents.*

6. Other requirements that are preferred to be turned in *with* your application include (a) the physical form with immunizations and (b) CPR certification. These are required to be completed and turned in by the date of Camp DNR (August 20, 2024).

7. Student admission will be conditional pending a negative drug screen and eligibility for licensure by the Texas Board of Nursing (TBON). After application deadline, all applicant information is submitted to the TBON for a background check. More information about this will be given with your acceptance letter.

8. All accepted candidates must attend the General Session on July 9, 2024 at 10 a.m. (class position forfeited if you do not attend)

9. All accepted candidates must attend Camp DNR on August 20-21, 2024, 8 a.m. - 4 p.m. (class position forfeited if you do not attend)
