**COURSE DESCRIPTION:** This course covers a study of the legal concepts of real estate, land description, real property rights, estates in land, contracts, conveyances, encumbrances, foreclosures, recording procedures, and evidence of title.

**COURSE OBJECTIVES:** The student will demonstrate a working knowledge of the Texas real estate contract forms; know state laws that regulate the use of real estate contracts; understand and describe definitions pertaining to legality of realty; write realty contracts that will be enforceable in a court of law; and know which forms can be utilized in conjunction with promulgated addenda.

**TEXTBOOKS AND MATERIALS:** Students will need a copy of the book Texas Real Estate Law, revised 11<sup>th</sup> edition. ISBN: 9781133435075. Please verify that the book purchased is the correct edition. Students will also need internet access to the Texas Real Estate Commission web page to find and print the newest versions of needed forms. A calculator will be needed on occasion.

**ATTENDANCE:** Students are expected to regularly and timely attend class. Excessive absences (more than 3), or cases of extreme tardiness may result in the student being dropped from the course without notice. Please refer to the student handbook for more information. Upon missing the third class period, I will initiate the drop no questions asked. Due to the large quantity of information covered and us meeting once weekly, students are encouraged to attend each meeting.

**CLASSROOM ETIQUETTE:** Real Estate agents will want to conduct themselves in a professional capacity once in the work force. Reputation and client service is the key to success in this business. ### **Lubbock Center Campus Guidelines**
