Course Description:

A survey of the social, political, economic, cultural, and intellectual history of the United States from the Civil War/Reconstruction era to the present. United States History II examines industrialization, immigration, world wars, the Great Depression, Cold War and post-Cold War eras. Themes that may be addressed in United States History II include: American culture, religion, civil and human rights, technological change, economic change, immigration and migration, urbanization and suburbanization, the expansion of the federal government, and the study of U.S. foreign policy.

Course Objectives:

- 1.**critical thinking:** to include creative thinking, innovation, inquiry, and analysis, evaluation, and synthesis of information.
- 2.**communication:** to include effective development, interpretation and expression of ideasthrough written, oral and visual communication.
- 3.**social responsibility:** to include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities.
- 4.**personal responsibility:** to include the ability to connect choices, actions, and consequences to ethical decision-making.

Course Purpose: To acquaint students with the diversity of American history and to promote critical thinking in interrelating the past to the present. Fundamentally, the course promotes general understanding of a body of knowledge any student should know.

Course Requirements: To maximize a student's potential to complete this course, he/she should attend all class meetings, complete all homework assignments and examinations in a timely manner, and complete all other projects or papers as assigned in the instructor's specific instructions.

Course Evaluation: See the instructor's course information sheet for specific items used in evaluating student performance.

Assignments

The course requires the student to complete thirteen textbook assignments during the semester. Each textbook assignment includes an objective test (multiple choice questions) and an essay test for each chapter assigned. The tests will be available on the first day of class. Tests may be taken early, but they **may not** be taken after the due date (11:30 PM on the due date) has passed. Students are allowed 45 minutes to take each test.

Textbook Assignments

Chapter quizzes The student will carefully read the required chapters in the textbook and take an online quiz (located under assessments on the course homepage) over the specified chapter during the designated time. Once you begin the quiz you cannot stop. You are only allowed **one opportunity** to take each quiz. **Note: Once you click "begin quiz" you must complete the quiz in its entirety.** Questions not completed during the allotted time will be counted wrong.

Chapter Essays After reading the chapter the student will take an essay quiz over that chapter. As with the objective quizzes, the essay quiz must be completed within a specified time limit. Essay answers must be written in paragraph form with complete sentences, correct grammar, spelling and punctuation and no abbreviations. The student must answer the question with a full discussion and explanation, **providing details** and specifics that indicate a knowledge and understanding of the material. (length of essay: one-half page if single spaced, one page if double spaced will be considered **minimum**)

Grading Policy

The course grade will be based on an average of the textbook assignments. Each textbook assignment will consist of a chapter quiz worth fifty points and a chapter essay worth fifty points. These will be combined to produce one grade. (Ex. A grade of 40 on the Multiple Choice Quiz and a grade of 35 on the Essay will give the student a grade of 75 for that Chapter test) An average of these assignments will determine the course grade. No extra credit is available in this course.
