GENERAL COURSE INFORMATION

COURSE DESCRIPTION

Development of skills and techniques required for a comprehensive nursing health assessment within a legal/ethical framework. This course lends itself to a blocked approach. Topics include knowledge, skills, andprofessional values. Through classroom and interactive experiences, the students explore basic concepts and skills related to physical assessment of diverse clients. The student will describe the components of a comprehensive health assessment and demonstrate competency performing an adult physical assessment. Pre-requisite: ENGL 1301, BIOL 2401, BIO 2420, PSYC 2314, and a 3-hour humanities elective, with a grade of "C" or better. Concurrent enrollment of RNSG 2307 and RNSG 2260. Failure of RNSG 1115 will require dropping and repeating RNSG 2307 and RNSG 2260.

STUDENT LEARNING OUTCOMES

At the completion of the semester students will:

- 1. Provide care based on current knowledge, theory, and research.
- 2. Assume accountability and responsibility for practice.
- 3. Utilize principles of therapeutic communication with individuals.
- 4. Perform complete health assessments and documentation on individual clients.
- 5. Utilize information technologies to enhance knowledge base, retrieve information to support nursing practice and document nursing actions.

COURSE OBJECTIVES

EVALUATION METHODS

Teaching methods: classroom lecture, skills demonstrations, simulation, focus learning groups, and Course Point+ assignments. Possible online learning: Zoom, Blackboard Collaborate, and/or Microsoft Teams. This course will offer **face-to-face instruction** with online instruction provided to supplement and enhance learning. This course may take on a different format such as:

Evaluation methods: skills demonstration, individual assignments, SIMs/Lab recording sessions, CoursePoint+assignments, computer testing and Blackboard assignment submissions.

ADDITIONAL CLASSROOM ITEMS

Students should come to class prepared with pens, pencils, and a spiral notebook for taking notes or completed quizzes or assignments in class. Students are responsible to purchase a Stethoscope, Pen Light, and Pulse Oximeter and bring to class. Students should be prepared to take notes over lecture material if they choose. Students may be required to use a laptop computer or similar technology for exams and quizzes in the classroom. Students may use personal laptops in the classroom to take notes if desired. An I-pad will be checked out to each student for school use.

ATTENDANCE POLICY (*READ CAREFULLY)

Class Attendance

Students are expected to attend all classes to be successful in a course. The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus.

When an unavoidable reason for class absence arises, such as illness, an official trip authorized by the college or an official activity, the instructor may permit the student to make up work missed. It is the student's responsibility to complete work missed within a reasonable period as determined by the instructor. Students are officially enrolled in all courses for which they pay tuition and fees at the time of registration. Should a student, for any reason, delay in reporting to a class after official enrollment, absences will be attributed to the student from the first-class meeting.

Students who enroll in a course but have "Never Attended" by the official census date, as reported by the faculty member, will be administratively dropped by the Office of Admissions and Records. A student who does not meet the attendance requirements of a class as stated in the course syllabus and does not officially withdraw from that course by the official census date of the semester, may be administratively withdrawn from that course and receive a grade of "X" or "F" as determined by the instructor. Instructors are responsible for clearly stating their administrative drop policy in the course syllabus, and it is the student's responsibility to be

aware of that policy. It is the student's responsibility to verify administrative drops for excessive absences through MySPC using his or her student online account. If it is determined that a student is awarded financial aid for a class or classes in which the student never attended or participated, the financial aid award will be adjusted in accordance with the classes in which the student did attend/participate, and the student will owe any balance resulting from the adjustment.

The student can miss no more than two (2) hours of classroom lecture. A student missing more than two (2) classroom lecture hours will be dropped from RNSG 1115. The course leader may initiate the withdrawal of the student for any absences. Reinstatement is handled on an individual basis. Do not be tardy for lecture; this is disruptive to the rest of the class. Cellular phones must be turned off during the lecture period or while in the NLRL (nursing learning resource lab). NO CELL PHONES are allowed in the Center for Clinical Excellence.

Dropping a Class

Dropping a class will be initiated by the instructor. If a student is not successful in one or more of the following courses: RNSG 1115, RNSG 2307, or RNSG 2260. The instructor will meet with the student to discuss which class(es) will be dropped and which class(es) a grade will be assigned. (RNSG 1115, RNSG 2307, and/or RNSG 2260).

Withdrawing from All Classes

ASSIGNMENT POLICY

All assignments must be completed by the assigned due date. Failure to complete any assignment by due date will result in a **10-point deduction each day late up to 3 days**, at which time the student will receive a zero. Assignments, quizzes, exams, and skills missed due to an unexcused absence may not be made up. Assignments are due by the assigned dates and times in Central Standard Time (CST) on the class schedule. Students should contact faculty prior to the due date and time if they anticipate material will be late. Please note contacting faculty will not guarantee the receipt of an extension for the assignment. Please allow enough time for

preparation and submission of each assignment prior to the scheduled due date. Student must scan required documents before uploading intoBlackboard. Scanners are located in the classroom and the video reviewing room. Students may also choose anapp of choice (I-scan, etc.). Assignments must be uploaded as a PDF.

LIPPINCOTT'S COURSEPOINT+ ASSIGNMENTS

Student will complete assignments in Lippincott's CoursePoint +. These assignments link directly back to the Taylor's Fundamentals of Nursing text. Reading and comprehending this text will be crucial to your success in this course. Please see course calendar for due dates. These assignments will include pre-lecture quizzes. Students have three attempts to achieve the highest grade desired. The average of all CoursePoint+ assignments by each due date will account for **50 points** of the final course grade. Course code will be located on blackboard to assist in enrollment.

QUIZZES

Student will be required to complete three (3) quizzes, refer to calendar for dates of quizzes. Each quiz will be worth 150 points each, for a total of <u>450 points</u> of the final course grade. Quizzes will vary in the number of questions, not to exceed 100 questions; however, the student will receive 1.5 minutes per question to complete the exam. Quizzes will be taken by computerized testing. Any quiz not completed during the assigned time frame will receive a zero. If a student makes less than 115.5 points (77%) on an exam, see the exam remediation below.

EXAM REMEDIATION

Remediation is one essential component to ensure student success. Therefore, any student scoring below 115.5 points (77%) on any exam is required to make an appointment with an instructor prior to the next exam and then maybe referred to the retention/remediation counselor as designated by the instructor. The student will be required to follow up with the retention/remediation counselor as indicated.

HEALTH HISTORY DOCUMENTATION

Students will complete a health history on a peer. Health History documentation can be found on Blackboard under Course Content. Health History Documentation will be submitted under the assignment link in blackboard by the due date specified on the class schedule. The Health History Documentation will account for **50 points** of the final course grade.

HEALTH ASSESSMENT GOREACT VIDEO UPLOADS

Students will record three different assignments using GoReact, a recording software that is hosted through Blackboard. The student will be required to film a video health assessment covering the first 2 class times, the last 2 class times, and then a full head-to-toe assessment. The student will film this skill on a family member or peer, modesty must be always maintained throughout the video and **the participant must verbally consent to being filmed on the video prior to starting your assessment in each recording.** The recording is directly uploaded to Blackboard where it will be graded. Any evidence of cheating, prompting, or assisting from the student/participant that is recording the skill(s) will be deemed as academic dishonesty and grounds for failure of the course and/or dismissal from the nursing program. The student will have no more than two recording sessions prior to submitting the video for grading. If the recorded video submitted for grading is failed, a second opportunity will be allowed following documented lab practice as determined by the instructor and remediation plan. Remediation plan will be made and completed before the student can schedule a second appointment. The student will have no more than two recording sessions prior to submitting the video for the second grading. If the video is failed on the second attempt, a third opportunity will be allowed following completion of a second remediation plan given by instructor. If the video is not

passed on the recording turned in for the third submission, this will result in a failure of the course. The three video recordings will account for **50 points** of the final course grade.

SIMULATION ORIENTATION

Students will be required to attend and complete the simulation orientation forms. The simulation orientation will be at the Center for Clinical Excellence on the Reese Campus as designated on the calendar. Simulation Orientation information can be found under Simulation Orientation Blackboard Module. Simulation Orientation paperwork will be submitted under the assignment link in blackboard by the due date specified on the class schedule.

PHYSICAL ASSESSMENT

The student will be required to complete a head-to-toe physical assessment on a client in the Center for Clinical Excellence simulation lab on Reese campus. Students must complete all critical elements, denoted by an * on the Physical Assessment Grading Criteria and achieve at least 231 points (77%) to pass the physical assessment and to pass RNSG 1115. Each section on the grading criteria is denoted with specified points. Completing all the * critical elements on the Physical Assessment Grading Criteria gives the student a 77 on the physical assessment checkoff. Once the head-to-toe physical assessment has been successfully passed the grade will account for 300 points of the overall grade for RNSG 1115. If unsuccessful on the first attempt (missing any * critical element) the student will be required to remediate and record a physical assessment on a peer/manikin in the Nursing Learning Lab in the Allied Health Building. At the discretion of the instructor, you may be allowed to repeat only the items missed for the second attempt. On the second attempt each section on the grading criteria, missed on the first attempt will be worth half the points listed on the rubric. The points for areas completed correctly will be added to original grade for a final grade on the physical assessment. Again, noting all * critical elements must be completed correctly to get the additional points and to pass the Physical Assessment. On the third attempt each section on the grading criteria, missed on the first and/or second attempt will be worth one quarter of the points. The points for areas completed correctly will be added to original grade for a final grade on the physical assessment. Again, noting all * critical elements highlighted must be completed correctly to get the extra points and to pass the Physical Assessment. Failure to complete all * critical elements on the Physical Assessment Grading Criteria on the first, second, or third attempt or not completing by the designated due date specified on the calendar will result in a failure in this course. Review grading criteria and additional instructions under Physical Assessment learning module located under course content in Blackboard.

REMEDIATION POLICY

Students who fail the first attempt on the head-to-toe physical assessment will be required to complete a remediation plan prior to scheduling to record the second attempt on a peer/manikin. The student will have nomore than two recording sessions prior to submitting the second attempt physical assessment recording to instructor for grading.

SPECIAL INSTRUCTIONS WHEN PERFORMING A PHYSICAL ASSESSMENT

Students must arrive in full SPC uniform for the Simulation Orientation at the Center for Clinical Excellence, totest for the physical assessment at the Center for Clinical Excellence or the Nursing Learning Lab. A student may receive deductions and/or be sent home for noncompliance of the SPC Uniform Policy. Cell phones or smart watches are not allowed in the clinical setting. Failure to comply will result in the student being sent home, resulting in a zero for the simulation physical assessment.

ADDITIONAL PRACTICE

At any time, a faculty member can require a student to complete additional practice in the simulation lab or thenursing learning lab to ensure student and client safety in clinical. Students are required to maintain proficiency in all skills.

PHYSICAL ASSESSMENT DOCUMENTATION

The student will be required to complete documentation of their head-to-toe physical assessment on a client inthe Center for Clinical Excellence simulation lab on Reese campus. Physical Assessment will be submitted under the assignment link in blackboard by the due date specified on the class schedule. The Physical Assessment Documentation will account for **100 points** of the final course grade. See additional instructions under Physical Assessment Documentation module located under course content in Blackboard.

COMPUTER USAGE

As computer technology in the field of health occupations continues to become more popular, computers will beused in this course for several assignments. All students have access to computers and printers on the South Plains College campus. Students will be expected to utilize computers to access assignments and classroom resources. All registered students are supplied with a working email account from South Plains College. In order to take exams, students must have their username and password. ALL STUDENTS ARE EXPECTED TO KNOW THEIR SPC STUDENT USERNAME, PASSWORD AND STUDENT ID.

COMPUTER LAB USAGE

The computer lab(s) on any campus may be used by students during scheduled open hours or as assigned by aninstructor. Printer paper will not be provided for students to print materials, but students may seek assistance from faculty or staff to request lab paper from the college if needed. Lack of computer lab paper is not an excuse for not having homework assignments, skills lab sheets, or any other required documents. Students should come prepared for class.

Cell phones, smart watches, athletic Fitbits, student badges, personal calculators or any electronic learning device of any kind are not allowed in the computer lab at any time during testing. All caps and large heavy jackets are to be left in the classroom or your vehicle during testing. Backpacks, handbags, food, or drink are notallowed in the computer lab at any time.

All * critical elements highlighted on the Physical Assessment Grading Criteria must be passed first in order to pass RNSG 1115. Failure to pass all * critical elements on the Physical Assessment Grading Criteria by specified date on the calendar will result in a F for RNSG 1115. The student must achieve 770 points or greater to pass RNSG 1115. To pass RNSG 1115 you have to pass the physical assessment and then have a grade of 231 points (77%) and complete all critical elements denoted by a * on the rubric.

Working within the healthcare field can be stressful and requires a mentally tough individual to provide medicalcare in the hospital environment. To better prepare students for a career in the healthcare profession, there will be times during this course where students will be exposed to training scenarios and situations that will be unpleasant to the average college student. If the student does not feel they can tolerate this type of learning environment, they should discuss this with me immediately before continuing the course. Additionally, enrollment in this course does not guarantee a passing grade, successful completion of the nursing curriculum, or NCLEX-RN examination.

4.1.1.5 Campus Concealed Carry Statement

Texas Government Code 411.2031 et al. authorizes the carrying of a concealed handgun in South Plains College buildings by individuals and in accordance with Texas Government Code 411.209 (a). All holders of a valid Texas License to Carry may carry on their person a handgun that is concealed in accordance with Texas Penal Code 46.03 (a-2). Qualified law enforcement officers or those who are otherwise authorized to carry a concealed handgun in the State of Texas are also permitted to do so. Pursuant to Penal Code (PC) 46.035 and South Plains College policy. Individuals may not carry a concealed handgun in restricted locations. Texas Senate Bill 11 allows for the carrying of concealed handguns on Texas public institution campuses by individuals holding a valid Texas License to Carry (LTC) or Concealed Handgun License (CHL).
