#### GENERAL COURSE INFORMATION

- A. **Course Description:** (3:2:2) This course is one in a series of courses in basic preparation for a new firefighter. It should be taken in conjunction with Firefighter Certification I, II, IV, V, VI, and VII to satisfy the Texas Commission on Fire Protection (TCFP) curriculum for Basic Structural Fire Suppression, Course #100.
- B. **Course Goals/Objectives:** The student will demonstrate competencies, for subjects taught, set forth in the TCFP curriculum for Basic Fire Suppression.
- C. **Course Competencies:** Letter grades are assigned as follows:

# B. **Attendance Policy:**

- Punctual and regular attendance is required of all students.
- A class is defined as a four-hour block of instruction.
  - Saturdays have eight hours of instruction scheduled.
    Therefore, each Saturday is the equivalent of two class days and all-day absences on Saturday count as two absences.
- Attendance is 15% of your overall semester grade
  - You begin the semester with 100.00% attendance score
    - Non-excused absence = 7.50% deduction
    - Late to class = 2.25% deduction
  - Students who drop below 70.00% attendance score will be subject to expulsion from the SPC Basic Structural Firefighter Academy.
- Students are responsible for all class work covered during any absence from class.
- Excused absences for scheduled military training, funerals, major medical emergencies, etc. may be allowed. Proof must be submitted (training orders, obituary, doctor's note, etc.) to be considered excused.

# C. Assignment Policy:

- All required work must be completed and submitted on time or be subject to penalty points (5 penalty points for each day late.)
- Periodic TCFP quizzes will be administered approximately every 2 weeks and will cover approximately 50 hours of instruction.
- The SPC Basic Structural Firefighter Academy comprehensive fall semester final exam (academy midterm) will be administered at the end of the semester. All students are required to take the academy midterm. A passing score of 70.00% must be achieved on the academy midterm to receive permission of the program coordinator to enroll in the spring semester of the SPC Basic Structural Firefighter Academy. (TCFP Rule)

D. **Grading Policy:** A weighted grade system will be utilized to determine the final grade for each student. Grades will be determined by dividing the total points earned by the total points possible in each area (quizzes, attendance, and the final) and multiplying those results by the respective grade weights:

Area	Percentage of Semester Grade
Module Quizzes	= 10% of Semester Grade
eBook Quizzes	= 10% of Semester Grade
TCFP Quizzes	= 50% of Semester Grade
Midterm	= 15% of Semester Grade
Attendance	= 15% of Semester Grade

Up to 7.5% extra credit is available through both completion of workbook chapters (5% possible) and via voluntary community service (2.5% possible; 0.5% earned per 4 hours worked at specific events). See instructor for further details if you are interested.

- The fall semester of the SPC Basic Structural Firefighter Academy is made up of four classes. The semester grade you earn is applied to all four classes.
  - o If you finish the semester with an "A", you will receive an "A" in all four fall semester Fire Academy (FIRS) classes.
  - o If you finish the semester with a "B", you will receive an "B" in all four fall semester Fire Academy (FIRS) classes.
  - If you finish the semester with a "C", you will receive a "C" in all four fall semester Fire Academy (FIRS) classes.
  - If you finish the semester with a "D" or "F", you will receive that grade in all four fall semester Fire Academy (FIRS) classes and be ineligible to enroll in the spring semester of the SPC Basic Structural Firefighter Academy.

- Regardless of your "Semester Grade", a passing score of 70.00% <u>must</u> be achieved on the academy midterm to receive permission of the program coordinator to enroll in the spring semester of the SPC Basic Structural Firefighter Academy.
  - For example, if you have a 100% average, perfect attendance, complete all the available extra-credit, and score a 69.99% on the midterm, you WILL NOT RECEIVE PERMISSION TO ENROLL IN THE SPRING SEMSTER (TCFP rule).
