<u>COURSE DESCRIPTION</u>: This course is a study of the central purposes and functions of an appraisal, social and economic determinants of value, appraisal case studies, cost, market data and income approaches to value estimates, final correlations, and reporting.

<u>COURSE OBJECTIVES</u>: Students will be able to determine the scope of work for an appraisal, determine the opinion of value of residential and investment properties based on numerous approaches, and lastly be able to work through the URAR report and associated data. Based on this students will better understand the appraisal process and how it affects their clientele.
