<u>COURSE DESCRIPTION</u>: This course is the study of the role of the property manager, property owner, policies, operational guidelines, leases, lease negotiation, tenant relations, maintenance, reports, habitability laws, and the Fair Housing Act.

<u>COURSE OBJECTIVES</u>: Students will understand effective practices of a real property manager; understand the legalities of the Fair Housing Act; negotiate, execute, and enforce real estate management contracts and leases; maintain rapport with tenants and owners; knowledge of maintenance of real property.

<u>EXAMINATION POLICY</u>: There will be three examinations, including a comprehensive final examination. Exams will be composed of objective (multiple choice and true/false) questions. The final examinations will be composed of essay and contract forms, which will need to be filled in on the appropriate TREC forms. From time to time the instructor may elect to give pop quizzes.

<u>ASSIGNMENTS</u>: Students are expected to attend class having <u>previously read the assigned chapters</u> and having completed all of the required assignments. Students should be prepared to discuss the readings assigned. Assignments must be completed by the student. Any attempt to cheat or plagiarize material that is not yours will result in a grade of zero. The matter will then be passed on to the Department Chair, and if need be a higher authority.

<u>ATTENDANCE</u>: Students are expected to regularly and timely attend class. Excessive absences (more than 3), or cases of extreme tardiness may result in the student being dropped from the course without notice. Please refer to the student handbook for more information. Upon missing the third class period, I will initiate the drop no questions asked. Due to the large quantity of information covered and us meeting once weekly, students are encouraged to attend each meeting.
