<u>COURSE DESCRIPTION</u>: This course is an overall review of real estate and an assessment of what the student has learned. This course will also help the student prepare for the Texas Real Estate License Exam. The course content includes a review of the basic real estate principles, finance, mathematics, appraisal and law. This course is designed to measure the knowledge and competence of the student.

<u>COURSE OBJECTIVES</u>: Students will review the basics of real estate and the applicable state laws for the state of Texas; students will have a basic understanding of the unauthorized practice of law and which promulgated forms achieve the desired results of the transaction; lastly students will be tested for their overall competence and knowledge of real estate.

<u>TEXTBOOKS AND MATERIALS</u>: Students will need a copy of the book, "Guide to Passing the Pearson VUE Real Estate Exam", by Pivar, 9<sup>th</sup> edition. ISBN: 9781475426137. Please verify that the book purchased is the correct edition. Students will also need internet access to the Texas Real Estate Commission web page to find and print the newest versions of needed forms.
