**Course Level:** Introductory

**Course Description:** Instruction in the artistry of hair design. Topics include theory, techniques, and application of hair design.

**End-Of-Course Outcomes:** Demonstrate workplace competencies related to the artistry of hair and perform the professional skills o hair design.

- Perform analysis of hair structure.

- Confer and organize analysis of hair growth.
- Differentiate in hair distribution.
- Use information and tools in the artistry of hair.
- Produce hairstyles using elements of good hair design.
