GENERAL COURSE OUTLINE

Course Level: Advanced

Course Description: Advanced concepts in the theory and practice of hair design.

End-Of-Course Outcomes: Identify terminology, demonstrate proper techniques related to hair design, and exhibit workplace competencies.

- Utilize the techniques related to hair design.

- Recognize and perform workplace competencies in hair design.
- Create an original hairstyle using design elements
