COURSE DESCRIPTION

A study of neonatal and pediatric cardiopulmonary care that covers advanced concepts of acute care, monitoring, and management as applied to the neonatal and pediatric patient.

1. The student will develop the ability to make decisions in the neonatal/pediatric environment, specifying therapeutic goals, considering treatment alternatives, considering risks, and choosing the best treatment approach. (F-8)
2. The student will recognize common problems in neonatal/pediatric respiratory care and design an appropriate plan of action. (F-9)
3. The student will gain an understanding of the cardiopulmonary development from the fetal period through childhood, including the development and function of the integral parts. (F-1, F-2, F-10)
4. The student will develop the ability to evaluate and interpret the data acquired from a prenatal and perinatal history, and gain an understanding of the transition from fetus to neonate. (C-5, C-6, C-7, C-8)
5. The student will acquire data through physical examination and laboratory and radiologic assessment of a child, and use this data to determine the cause and treatment of common pediatric pulmonary disorders. (F-10, F-11, F-12, C-5, C-6, C-7, C-8)
6. The student will acquire data through physical examination and laboratory and radiologic assessment of a child, and use this data to determine the cause and treatment of common congenital cardiac defects. (F-10, F-11, F-12, C-5, C-6, C-7, C-8)
7. The student will gain an understanding of the non-invasive monitoring of children, including the selection of equipment, understanding proper set-up and operation of that equipment, distinguishing trends in data, and troubleshooting malfunctions. (C-16, C-18, C-19, C-20)
8. The student will gain an understanding of the various pediatric/neonatal respiratory treatment modalities, including the selection of equipment, understanding proper set-up and operation of that equipment, distinguishing trends in data, and troubleshooting malfunctions. (C-16, C-18, C-19, C-20)
9. The student will gain an understanding of the use of continuous distending pressure and mechanical ventilation in children, including the selection of equipment, understanding proper set-up and operation of that equipment, distinguishing trends in data, and troubleshooting malfunctions. (C-16, C-18, C-19, C-20)

All competencies will be documented in Trajecs by the SPC instructor evaluating the student. The student is not considered proficient in lab competencies until a satisfactory rating has been achieved. The student will be evaluated as:

- Satisfactory (100%)** - Ready for clinical application with minimal supervision. Performed procedure accurately.
- Unsatisfactory performance (0%)** - Not ready for clinical application.

Requires remediation under one of the following categories:

- **Unsatisfactory 1st attempt (0%):** Requires additional lab practice and complete re-evaluation of the procedure. If the student receives Unsatisfactory on 1st attempt, the student may attempt the competency on another lab day after reviewing the procedure, unless notified otherwise by the instructor. An Unsatisfactory 1st attempt will be documented in Trajecs and a grade of zero (0%) will be recorded in the gradebook.
- **Unsatisfactory 2nd attempt (0%):** Requires additional lab practice and complete re-evaluation of the procedure. If the student receives an Unsatisfactory on 2nd attempt, the student must attempt the competency on another lab day after meeting with the instructor and following a documented remediation plan. The documented remediation plan will be customized to meet the students' deficiencies. An Unsatisfactory 2nd attempt will be documented in Trajecs, a grade of zero (0%) will be recorded in the gradebook, and 3rd attempt will be recorded for verification.
- **Unsatisfactory 3rd attempt (0%):** The student will meet with the instructor to review the unsatisfactory items documented in the recording. The student is unable to proceed with the program but will be allowed to withdraw from the course with a "W". If the student chooses not to withdraw personally, they will receive an "F" for the course.

Each competency attempt will be scored as "Satisfactory (100%)" or "Unsatisfactory (0%)" and included in the Lab Competency Grade. Students must complete every competency with a Satisfactory rating to complete the course.

Failure to complete all competencies with satisfactory performance will jeopardize the student's ability to continue in the program.

ASSIGNMENTS (10%)

Students are expected to maintain a reading schedule at home to keep current with classroom discussions. We also encourage reviewing the OneVision supplemental content prior to coming to class. Content-specific links will be provided in Blackboard. Unit assignments, simulations, and quizzes will be posted in Blackboard with due dates. **Late assignments will not be accepted.**

UNIT EXAMS (40%)

There will be four unit exams. Make-up exams will not be given, and no exams will be dropped.

FINAL EXAMINATION (25%)

The Final Exam will be comprehensive.

We will be utilizing Honorlock within Blackboard Ultra to administer exams. You will need to have a working camera on your computer to take these exams. PLAGIARISM

Offering the work of another as one's own, without proper acknowledgment, is plagiarism; therefore, any student who fails to give credit for quotations or essentially identifiable expression of material taken from books, Internet resources, encyclopedias, magazines and other reference works, or from the themes, reports or other writings of a fellow student, is guilty of plagiarism. This class will be using Turnitin as a means to score assignment plagiarism scores. A plagiarism score of 15% - 20% is considered acceptable. **If found cheating or plagiarizing, the student's future in this program will be based on the decisions from the Allied Health Departmental Director's Committee.**

AI-GENERATED CONTENT

While all assignments are expected to be the original work of the student, with EXPRESS content of the DCE, the use of Artificial Intelligence (AI – ChatGPT, Bard, Bing, etc.) in the course is allowed. Acceptable AI use in this class includes one or more of these:

- Brainstorming & Researching: Use AI to generate research articles or summaries on disease processes or lab values.
- Fact-checking: Verify information by checking sources with the use of different AI tools.
- Language assistance: Use AI to help with grammar and clarity in writing.

In the event you utilize AI for any of the above, you **MUST** properly cite the generated AI content you used in your assignment. This class will be using Turnitin, and as a means to score assignments, AI-generated content scores. An AI-generated content score of 15% - 20% is considered acceptable.

Failure to follow this guidance and the use of AI beyond the boundaries stated is a violation of the SPC Academic Integrity policies.

ATTENDANCE

CLASSROOM ATTENDANCE

It is imperative that students in all programs adhere to this attendance policy. Consistency in attendance expectations ensures that all students have a fair and equitable opportunity to succeed in their academic endeavors.

- Regular attendance is mandatory for all classes. Students are expected to attend all scheduled class sessions, including lectures, labs, and other instructional activities.
- Students who accumulate excessive absences may face consequences that impact their grades and overall success in the program.

Students are expected to attend all classes in order to be successful in a course. The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus. When an unavoidable reason for class absence arises, such as illness, an official trip authorized by the college or an official activity, the instructor may permit the student to make up work missed. It is the student's responsibility to complete work missed within a reasonable period of time as determined by the instructor. Students are officially enrolled in all courses for which they pay tuition and fees at the time of registration. Should a student, for any reason, delay in reporting to a class after official enrollment, absences will be attributed to the student from the first class meeting.

Students who enroll in a course but have "Never Attended" by the official census date, as reported by the faculty member, will be administratively dropped by the Office of Admissions and Records. A student who does not meet the attendance requirements of a class as stated in the course syllabus and does not officially withdraw from that course by the official census date of the semester, may be administratively withdrawn from that course and receive a grade of "X" or "F" as determined by the instructor. Instructors are responsible for clearly stating their

administrative drop policy in the course syllabus, and it is the student's responsibility to be aware of that policy. It is the student's responsibility to verify administrative drops for excessive absences through MySPC using his or her student online account. If it is determined that a student is awarded financial aid for a class or classes in which the student never attended or participated, the financial aid award will be adjusted in accordance with the classes in which the student did attend/participate and the student will owe any balance resulting from the adjustment.

Regular attendance is necessary to successfully meet the course objectives. The student is responsible for all classwork covered during absences from class. Students are expected to be in class on time. A student is tardy if he/she arrives more than 5 minutes after class begins. If a student is tardy to class three times, it will be counted as one absence. It is the student's responsibility to inform the instructor of the reason for an absence and to do so in a timely fashion. A student may be administratively withdrawn from the course if he/she has more than **three** absences from class and the instructor determines the student is unable to successfully meet the course objectives. **Work schedule** is **not** an excuse for missing class.

In extenuating circumstances, students are allowed to attend class virtually if not able to attend in the traditional classroom. Students attending virtually are required to be in a learning environment, present for the entirety of the class, and visible on camera at all times to be considered "present". Should students opt to have their camera off, not be dressed in appropriate attire, not be in an appropriate learning environment, or not be present for the entirety of the class, the instructor will consider this a classroom absence.

Again, virtual attendance will be allowed only under approved circumstances. Students must notify the instructor at least one hour before the class starts and receive instructor approval before attending virtually.

SKILLS LAB ATTENDANCE

Skills lab sessions are conducted on Tuesday and/or Thursday. Students are solely responsible for documenting their attendance in Trajecsyst for the skills lab. Students are required to attend sessions based on the schedule provided in Blackboard and are **allowed 1 skills lab absence**. It is the student's responsibility to inform the instructor at least one hour before the lab start time of the reason for an absence. Students are required to document the occurrence in Trajecsyst within 24 hours of the absence and obtain the content missed from the provided resources.

Competency check-offs missed will have to be coordinated with the Skills Lab Instructor at the Instructor's convenience. **Any additional skills lab absence is a 2-point deduction per occurrence from the student's final grade for RSPT 2453.** Students cannot proceed in the program unless all competencies are successfully completed.

To ensure successful completion of lab activities, students are expected to arrive on time. Students who arrive late assume responsibility for any missed content and must seek appropriate resources to make up the material. The Skills Lab Instructor is not obligated to repeat or reteach material that was covered before the student's arrival. A student is tardy if he/she arrives more than 5 minutes after lab instruction begins. If a student is tardy to lab three times, it will be counted as one skills lab absence. Tardy students are asked to respect their peers and enter the skills lab quietly in order not to disrupt the class. Students who are more than 15 minutes late for the skills lab instruction will be marked absent.

COMMUNICATION

Electronic communication between the instructor and students in this course will utilize the South Plains College "My SPC", email systems and via GroupMe app. Text messaging may also be used for communication. The instructor will not initiate communication using private email accounts.
