**It is the responsibility of each student to be familiar with the content and requirements listed in the course syllabus. **

COURSE DESCRIPTION

An applied systematic study of the structure and function of the human body. Includes anatomical terminology, cells, tissues, and the following systems: integumentary, skeletal, muscular, nervous, and endocrine. Emphasis on homeostasis.

COREQUISITE COURSES Required for application to the PTA Program: Math 1314, ENGL 1301, HUMA, PHYS 1410, PSYC 2314

STUDENT LEARNING OUTCOMES

After the semester, students will: Identify the structure and explain the function of cells and tissue; identify the components and explain the physiological mechanisms of the following body systems: integumentary, skeletal, muscular, nervous, and endocrine; and apply anatomical terminology to describe the processes these systems use to maintain homeostasis of the human body.

1. Construct, define, and utilize medical terms related to anatomy & physiology using word roots, suffixes, prefixes.
2. Explain anatomical planes, positions, and movements related to anatomy & physiology
3. Describe the basic functions of the cardiovascular and respiratory systems.
 - a. Identify the anatomy of the human heart
 - b. Describe the path the blood takes through the vascular system
 - c. Differentiate between arterial and venous components of the vascular system
 - d. Explain the blood flow through the heart
 - e. Identify the basic components of the respiratory system
 - f. Describe the various skeletal structures related to the respiratory system
 - g. Explain the process of breathing
 - h. Describe normal functions of the cardiopulmonary system.
4. Describe the basic functions of the integumentary system.
 - a. Explain the functions of human skin
 - b. Identify the components of the skin and the major structures within it
5. Describe the basic function of the Endocrine system.
 - a. Explain the function of our hormones
 - b. Identify the major producers and effects of hormones
6. Describe the basic function and anatomy of the neuromuscular system
 - a. Identify the major structures of the nervous system
 - b. Differentiate between sensory, motor, and autonomic nerves and their role in function
 - c. Describe the differences between the central and peripheral nervous systems
 - d. Identify the motor nerves that innervate the muscles of the body's regions, including head/neck, back, lower extremity, and upper extremity.
 - e. Identify nerves making up the Brachial Plexus
 - f. Identify Cranial nerves and the function of each nerve
7. Identify human bones and their actions related to normal movement of the body.
 - a. Identify the bones by name and location of the head/neck, back, upper extremity, and lower extremity.
 - b. Recognize important surface anatomy and landmarks associated with all regions of the body.
8. Identify human muscles and their actions related to normal function.
 - a. Demonstrate knowledge of OLAN of muscle in the human body

- b. Demonstrate knowledge of functional movement based on the action of the muscles of the head/neck, back, upper extremity, and lower extremity.
 - c. Identify the innervation of each of these muscles.
9. Explain how body systems interact to create normal functional human mobility

OUTCOME ASSESSMENT METHODS

Computer-based exams, written exams, written assignments, quizzes, Lab exams/quizzes, and other assignments and projects as assigned.

Grading Policy

Students who fall below the required minimum passing score of 70% will not be eligible to apply to the PTA program starting in the spring semester.

ASSIGNMENT POLICY

All assignments must be completed by the assigned due date. Late and/or incomplete work may be accepted, but with a grade deduction per day up to 3 days, and a grade of zero will be recorded at that time. Assignments, quizzes, exams, and skills checks missed due to an unexcused absence will be made up only with advanced notification of illness or emergency. Assignments are due by the assigned dates and times in Central Standard Time (CST) on the class schedule. Students should contact faculty before the due date and time if they anticipate material will be late. Please note that contacting faculty will not guarantee the receipt of an extension for the assignment. Please allow enough time for preparation and submission of each assignment prior to the scheduled due date to avoid issues with technology. Failure to complete any assignment by the due date will result in professional point deductions from the final grade. Assignments must be uploaded to Ultra as a Word Doc or PDF and labeled with the assignment title and student name.

EXAMS POLICY

The lecture exams will be administered via computer to prepare students for the rigor of the PTA Program. Possible pop quizzes may be handwritten, which will encourage memory and mastery of the material.

Additionally, many exam questions will be constructed to engage in critical thinking, allowing students to prepare for the rigors of high-stakes testing formats.

The exam policy includes the following:

- ❖ All summative assessments will be proctored by SPC faculty/Staff

STUDENT CONDUCT

Academic Integrity

It is the aim of the faculty of South Plains College to foster a spirit of complete honesty and a high standard of integrity. The attempt of any student to present as his or her own any work which he or she has not honestly performed is regarded by the faculty and administration as a most serious offense and renders the offender liable to serious consequences, possibly suspension.

Cheating - Dishonesty of any kind on examinations or on written assignments, unauthorized possession of examinations, the use of unauthorized notes during an examination, obtaining information during an examination from the textbook or from the examination paper of another student, alteration of grade records, unauthorized presence in faculty offices to obtain exam questions/answers, alter grades or otherwise change the outcome of any assessment, or assisting another students to do any of these activities are examples of cheating.

Plagiarism - Offering the work of another as one's own, without proper acknowledgment, is plagiarism; therefore, any student who fails to give credit for quotations or essentially identical expression of material taken from books, encyclopedias, magazines and other reference works, or from themes, reports or other writings of a fellow student, is guilty of plagiarism.

AI Usage - Dependence on AI tools can decrease human discretion and oversight. Students should not copy from any source, including AI, without prior approval and proper citation of the source. Students should not submit AI-generated work as their original work.

Complete honesty is required throughout all aspects of coursework, including all quizzes, exams, and assignments used to assess knowledge and/or skill. **Any assessment receiving a score of 0 or F due to cheating may result in the student being dropped from the course.**

Class/Lab Attendance Policy

Students are expected to attend all classes to be successful in a course. The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus.

- ❖ When an unavoidable reason for class absence arises, such as illness, an official trip authorized by the college or an official activity, the instructor may permit the student to make up work missed. It is the student's responsibility to complete work missed within a reasonable period as determined by the instructor. Students are officially enrolled in all courses for which they pay tuition and fees at the time of registration. Should a student, for any reason, delay in reporting to a class after official enrollment, absences will be attributed to the student from the first-class meeting.
- ❖ Students who enroll in a course but have "Never Attended" by the official census date, as reported by the faculty member, will be administratively dropped by the Office of Admissions and Records. A student who does not meet the attendance requirements of a class as stated in the course syllabus and does not officially withdraw from that course by the official census date of the semester, may be administratively withdrawn from that course and receive a grade of "X" or "F" as determined by the instructor. Instructors are responsible for clearly stating their administrative drop policy in the course syllabus, and it is the student's responsibility to be aware of that policy.
- ❖ It is the student's responsibility to verify administrative drops for excessive absences through Texan Connect using his or her student online account. If it is determined that a student is awarded financial aid for a class or classes in which the student never attended or participated, the financial aid award will be adjusted in accordance with the classes in which the student did attend/participate, and the student will owe any balance resulting from the adjustment.

- ❖ Absence-
 - ❖ If student misses more than 15 minutes of scheduled class time the student will be counted absences.
 - Excessive Absences – >3 with counseling after 2nd absences
- ❖ Tardy-
 - any time after class starts or returns from break. Notification prior to official class time will be considered on an individual basis.
 - 2 tardy = 1 absence

- ❖ Any absence from class should be reported to the instructor in advance whenever possible, or as soon as possible after the absence. This allows instructors to provide necessary support and address any missed coursework.

COMMUNICATION

Electronic communication between the instructor and students in this course will utilize the South Plains College “My SPC” and email systems. Text messaging may also be used for communication. The instructor will not initiate communication using private email accounts.
