**Course Description:** This is a course examining the operating of a small business. Emphasizes the functions including planning, leading, organizing, staffing, and controlling operations.

**Course Learning Outcomes:** The student will identify the aspects of operating a small business; describe human resource functions including employee development; explain the elements of total quality management; and compare purchasing procedures, inventory control, and computerized operations between/among small businesses.

**HOW THIS COURSE IS CONDUCTED:** This course is an online course, which means that you will access course information and respond to me and/or other students through the use of the Internet. Blackboard is used to deliver and manage this course, as well as Cengage Mind Tap. Blackboard and Cengage are software packages that are written to help manage online courses. You are encouraged to use the Blackboard course email to ask the instructor any questions you may have about the course etc.

## **Small Business Management, Longenecker, 18th Edition**

Textbook and Supplies: All that is needed for the course is a Cengage Unlimited Card. This will get you the access code to this class with E-Book and also the access code and E-Book for ALL Cengage textbooks you will use in other classes! If other instructors use a Cengage product in your other classes, you DO NOT need to buy anything else!!

The materials required for this course are included in Cengage Unlimited, a subscription service providing access to ALL Cengage ebooks and digital learning products—over 22,000—per semester (extended subscriptions also available). One Cengage Unlimited subscription can be used across all courses where Cengage products are assigned, at no additional cost. You can purchase access to Cengage Unlimited in the bookstore, or through my Blackboard course during the first week of class.

To access your course materials and explore Cengage Unlimited, log in to Blackboard and click on the link that says Cengage MindTap Weekly Assignments. When prompted, log in with your Cengage account and follow the prompts to complete the registration process.

### **REMINDERS FOR STUDENTS**

- What to purchase: You should NOT purchase BOTH individual course materials AND a Cengage Unlimited subscription—only ONE purchase is required. Cengage Unlimited is what you need! You just need to purchase one Cengage Unlimited Access Card for all of your Cengage classes!
- Start at the bookstore: You can go to the Levelland or Lubbock Reese SPC Bookstore to purchase the Cengage Unlimited Access code. It will be a physical card, with a scratch off code. Please scratch off gently!

You will get free 2-week trial access! But please do buy the code before the 2-week trial period ends, as you will be locked out of the course, after the 14-day period.

To access your course materials and explore Cengage, log in to Blackboard and click on the link that says Weekly Assignments. When prompted, create account/log in with your Cengage account and follow the prompts to complete the registration process.

**LOGGING INTO COURSE:** Under no circumstances are you allowed to give your User ID and/or password to anyone. If someone, besides you, is logging into this course, I will drop you immediately with an 'F', regardless of the reason.

**COMPUTER REQUIREMENTS:** I do not recommend any particular brand of computer. It is the responsibility of the student to make sure that they have the necessary computer resources and skills to take this class. Students are not required to purchase their own computer, but must have frequent regular access to one that meets specifications. There are computer labs available for student use on our Levelland, Lubbock Center, and Reese Center campuses.

### **Check Your Internet Access**

The computer you are using must be able to connect to the Internet to access the Blackboard website.

**To be able to participate in this online course, a student needs to have the following abilities:**

- Typing and word processing skills.
- Know basic functionality of a computer and how to do basic troubleshooting.
- Know how to connect to the Internet.
- Know basics of how the Internet works and how to search and conduct research using the Internet.
- Know how to attach and open documents in an e-mail message.
- Have basic file management skills.
- Know how to save and delete documents.

**ATTENDANCE POLICY:** Even though this is an online class, students still have to access the course on a regular basis. **Minimum log in for the course is at least four (4) days per week. Additionally, you should not let more than 72 hours pass without logging in.**

The Blackboard software used to manage this online course tracks student logins, tracking when and where the student has been in the course. Accessing this course on a regular basis is extremely important in order to meet the objectives of this course. Ideally, students should daily check the semester schedule, e-mail, and also check for announcements and fellow student discussions. This course is not 100% self-paced—there will be deadlines. You will feel more at ease with the materials if you stay in touch with what is going on. This course is 3 semester credit hours. For this reason, you should set aside a minimum of 6 hours per week to work on this course. One of the very first things you should do is set aside time each week to work on the class. It is very easy to put off attendance in an online course.

**A STUDENT IS RESPONSIBLE FOR INITIATING THEIR OWN WITHDRAWAL**, if that becomes necessary. A student who stops attending and stops completing assignments, must take the responsibility of contacting the Registrar's Office to drop the class.

I do not drop students for non-attendance. It is your responsibility to initiate the drop process if you decide not to complete the course. Students who stop attending and do not complete the coursework will receive an F at the end of the semester.

**Be advised – I do not accept late work for any reason.**

Late-Work and Coursework Extensions: No late coursework will be accepted. No extensions will be given for any coursework. There are two exceptions to this policy. **One, you are**

hospitalized and have intake and discharge paperwork from the hospital (not urgent care or note from Dr. visit). If this is the case, you must contact DeEtte Edens at [dedens@southplainscollege.edu](mailto:dedens@southplainscollege.edu) or at (806) 716-2376 and submit the required medical documentation to her. She will notify the instructor, if the illness warrants an extension. Two, you are on a SPC sponsored event and have sent in the proper documentation to me, **BEFORE** the trip/event has occurred.

**RESPONSE TIMES:** You should expect responses from me within 48 hours to emails sent using Blackboard email. **Cengage Mind Tap Case Study Homework (20%) -- Submitted in Cengage Mind Tap**

**Exams (40%)\*\*\*:** Exams (not including comprehensive final exam) covering 4-6 chapters each over the major areas of study related to small business operations listed under the course outline below plus the comprehensive final exam. Each exam will be released on Sunday mornings at 6:00 AM and will close on the following Sunday at 4:00p.m in Cengage Mind Tap. You will be able to click on the exam link and select the exam as soon as it is made available. When you begin the exam, you will have 1 hour and 15 minutes (75 minutes) to complete and submit the exam.

\*\*\* Exams will be conducted online within Cengage Mind Tap. (If you are not familiar with this software DO NOT WORRY! Guidelines and sign in procedures will be made clear in the first week of class. You will buy the Cengage Unlimited code to take exams and homework through this website—see the textbook info. above in the syllabus if you have questions regarding this.) Cengage will not allow printing of the exams when accessed. You will only be able to access the test once and you must take the test in one sitting—you will not be able to save and come back later to the test! It will be very important for you to visit the Semester Schedule in Blackboard to see when exams are scheduled. \*\*\*

**Certiport Required Certification Exam** = At the end of April 2026, you will be required to take the Entrepreneurship and Small Business Certiport Certification Exam. The test fee and practice exam fees are built into your tuition and have already been paid for! You will be able to practice for the exam throughout the entire semester with GMetrix software, which will be available for you to practice on your own. But you must come to a physical Certiport testing center on the Levelland SPC campus OR take the Certiport exam from your computer at home (monitored by a testing proctor), at the end of April 2026. You can schedule this exam around your schedule – testing center is located in Levelland. And you can also elect to test at home during a pre-scheduled appointment time.

I will give you an individual code for the practice software that you can use at your convenience on your own computer! I will also send you a code to take with you to the testing center when you schedule your exam. You have 2 takes for the exam! You can test once, see if you pass, and then re-test if you do not pass on the first take!

Please let me know if you have questions about this! Do not stress about this exam! It is required of ALL students who take this Small Business Operations course at SPC! This course is a capstone course for the Business Associate degree and this Certiport exam is an excellent certificate to hold, include on your resume, and for employers to see!
