Description: This course provides an introduction to basic script formats, terminology, and writing techniques for radio, television, and film. This course is a study of the techniques used in writing commercials, public service announcements, promos, news, documentary and fictional materials.

Supplies Needed: paper and pen/pencil for notes in class; folder or notebook where you can save notes, handouts, and graded assignments.

Course Requirements: Students should attend all class meetings and complete all assignments.

Textbook: None required.

Attendance and Tardiness Policy: I generally do not allow students to enter class after the first 5 minutes because it is disruptive If you repeatedly come to class after the 5 minute cut off, you will be asked to leave. Attendance in this class is required. There is a lot of classwork in this class that counts toward your final grade. Students are expected to attend all classes in order to be successful in a course. The student may be

administratively withdrawn from the course when absences become excessive as defined in the course syllabus below.

If a student misses more than 4 classes *throughout the semester*, I consider that number to be "excessive" and reserve the right to drop the student with an X or an F. I will warn you if you reach the 4 class limit. That will be your only warning.

Students with more than 4 absences *in a row* will be dropped from the class with an F or X without further warning.

Regardless of the reason for your absence, it is your responsibility to find out what work you miss. Please do not just e-mail me to ask what you missed and leave it at that or ask me what you missed 30 seconds before class starts. You must come to my office during office hours to discuss making up work. It is the student's responsibility to complete work missed within a reasonable period of time as determined by the instructor. Some work cannot be made up.

Students who enroll in a course but have "Never Attended" by the official census date, as reported by the faculty member, will be administratively dropped by the Office of Admissions and Records. A student who does not meet the attendance requirements of a class as stated in the course syllabus and does not officially withdraw from that course by the official census date of the semester, may be administratively withdrawn from that course and receive a grade of "X" of "F" as determined by the instructor. - Copying or using work done by another student.
- Citing sources you didn't use.
