Course Description

Selected composers and compositions will be studied through an interpretation of their historical, functional, and cultural significance. This course satisfies the core curriculum requirement for Visual or Performing Arts.

Learning Outcomes

1. Identify musical works and elements in a variety of styles.
2. Analyze the elements and structures of music using appropriate terminology.
3. Critically evaluate the influence of social, political, technological, and/or cultural ideas on music.
4. Articulate the significance of music as an art form within historical, cultural and social contexts.

Dual Credit Course Schedule

Online Course Format

This course is an asynchronous online course.

- Students are expected to attend classes online by logging into Blackboard and completing class readings, assignments, discussion questions, papers, and exams by the assigned deadlines.

Hardware Requirements

- You will need a computer or tablet capable of creating/editing documents, playing audio and video, joining video chats, etc.
- Smart Phones, while adequate for some course activities are not recommended for completing assignments, or taking tests within Blackboard
- Headphones or earbuds are recommended for listening exercises

Software Requirements

- Microsoft Word or equivalent software for creating document files to submit. All SPC students have access to Office 365 for Free!
- Students will need to use their official SPC student email for communication and to receive course announcements or alerts.

Withdrawal Policy

The last day to withdraw/drop with a grade of “W” is April 30. It is the student’s responsibility to withdraw from this course. Otherwise, students will be assigned their earned letter grade at the end of the course. Course averages will be updated weekly, and guidance will be provided throughout the term to help students decide whether they need to drop the class or not. Grade Book

The course grade book is maintained on Blackboard Ultra. The gradebook will be updated weekly. You are encouraged to log in regularly to keep track of your personal records. If you have questions about using this website, please do not hesitate to ask the instructor.

Exams

There will be five exams covering six historical periods.

1. Medieval: 400-1400/Renaissance: 1400-1600 (& Fundamental terms)
2. Baroque: 1600-1750
3. Classical: 1750-1825
4. Romantic: 1825-1900
5. Modern: 1900-Present (Exam 5 will include a comprehensive section.)
 - Each exam is worth 10% of the final grade average.
 - Exam materials will be drawn from class PowerPoints, text readings, unit assignments, and unit discussion questions.

Unit Assignments

There will be assignments, listening assignments, and discussion questions for each unit. Students must submit the completed assignments by the assigned deadline. Late assignments (up to one week late) will receive a 25-point deduction. Assignments not completed or completed after a week will receive an automatic zero.

Concert Paper

The student will **fully** attend one of the approved concerts listed and turn in a program and/or ticket stub along with a paper. The student will write a paper in which they discuss their reaction to the experience. The paper must follow these guidelines:

- 2 pages: typed, double spaced, Times New Roman 12pt font
- Must be chosen from one of the approved concerts listed on Blackboard.
- Must be submitted via Blackboard no later than the deadline stated in the course calendar. **Late papers will not be accepted.**
- A ticket stub or program must be submitted to Blackboard along with the typed paper. Failure to do

so will result in a 50-point deduction.

- Must answer each question or discuss each point outlined in the Concert Paper Instructions. Points will be deducted for unanswered questions or discussion topics that are not covered.
- **Projects which do not follow the above requirements will not receive credit.**

Class Deadlines

- Exams, Unit Assignments, and the Concert Paper deadlines will be announced in the Course Calendar.
- Exams will be taken on Blackboard and **must** be completed during the announced exam time/date.
- Unit Assignments will be completed and submitted on Blackboard and must be completed by the assigned deadline.
- The Concert Paper will be submitted on Blackboard and must be completed by the assigned deadline.
- It is the student's responsibility to access a reliable computer and internet connection.
- **"Computer/Internet problems" will not be an acceptable excuse for failing to submit an exam prior to the deadline or for submitting an incomplete exam.**

Late Work

- Unit Assignments, including Listening Assignments and Discussion Questions, completed up to one week after the posted deadline will receive a 25-point deduction. After one week, the late assignment will receive a zero.
- Exams will not be accepted after the due date, unless there are extenuating circumstances that are approved by the instructor. Late exams will receive a zero.
- Concert papers will not be accepted after the due date. Late papers will receive a zero.

Extra Credit

- Extra credit opportunities are not offered in this class. Make sure you keep up with weekly course work throughout the semester.

Communication via Email

Please use your SPC student email for communication with the instructor, and refrain from using Course Messages on Blackboard. Emails from students will be responded to within one business day. Emails sent by students after business hours, over the weekends, or during holidays should expect a delayed response on the next business day.

1. SPC will follow the recommended 3-day isolation period for individuals that test positive.
 - a. **Please note that day 0 is the date of positive test. Day 1 begins the first full day after the date of positive result.**
2. COVID reporting

- a. Please have students and employees notify DeEtte Edens, FNP-C if they have tested positive to verify dates before returning to class or work.
- b. The home tests are sufficient but students need to submit a photo of the positive result. The date of test must be written on the test result and an ID included in the photo. If tested elsewhere (clinic, pharmacy, etc.), please submit a copy of the doctor's note or email notification. Results may be emailed to DeEtte Edens, FNP-C at dedens@southplainscollege.edu.
- c. A student is clear to return to class without further assessment if they have completed:
 - The 3-day isolation period, symptoms have improved and
 - they are afebrile for 24 hours without the use of fever-reducing medication.
- d. **HEATH SCIENCE PROGRAMS ONLY:** Due to clinical requirements, students in health science programs returning to class or clinical from a positive test will be required to wear a mask in the health sciences areas including offices, hallways, and classrooms, as well as in the clinical setting for a 10-day period from date of positive test.

3. Please instruct students and employees to communicate with DeEtte Edens prior to their return date if still symptomatic at the end of the 3-day isolation.
4. Exposed individuals will not be required to quarantine. If exposed, SPC does request individuals closely monitor themselves. If an individual does become symptomatic, please do not attend class or work and be tested.

Artificial Intelligence Statement

· Purpose of Artificial Intelligence (AI) Applications:

AI applications such as ChatGPT, OpenAI, Bard, Grammarly, WordTune and others are advanced language models designed to aid and engage in meaningful conversations, as well as, generate and revise content. AI is intended to supplement learning, stimulate critical thinking, and enhance academic discourse. However, its use comes with certain responsibilities.

· Academic Integrity:

Using AI to generate academic work, including essays, reports, or assignments, without proper attribution is a violation of SPC academic integrity policies. Plagiarism undermines the learning process and is strictly prohibited. Students must ensure that their work reflects their own ideas, research, synthesis, and analysis and appropriately cites all sources, including AI.

· Collaboration and Consultation:

While AI can be a valuable resource, it is essential to strike a balance between seeking assistance and maintaining personal responsibility. Collaboration with peers, consulting instructors, and utilizing other approved learning resources should be prioritized. Overreliance on AI for solutions without actively engaging in the learning process is discouraged and can be grounds for academic integrity violations. Utilizing AI as a tool for brainstorming or research is allowed but the writing should be the student's own work and thoughts.

· Critical Thinking and Originality:

AI usage can provide suggestions and information, but it is essential to critically evaluate the responses and exercise independent thought. Relying solely on AI for answers deprives students of the opportunity to develop their analytical and problem-solving skills. In assignments where originality, creativity, and independent thinking are valued, AI would be detrimental to the student learning process. Critical thinking and originality emphasize the importance of independent thinking in all academic endeavors as part of the student's learning experience apart from outside influence and offers the student the opportunity to refine their unique, individual voice through academic discourse with other students and faculty.

· Ethical Use and Bias Awareness:

AI is trained on large amounts of data from the internet, which may include biased or inaccurate information. Be mindful of the potential for bias and critically evaluate the responses provided by AI. Therefore, when using AI, just like with using any other database, students must verify that the information is from reliable sources, question any potential biases, and ensure that the information and sources used in the paper are neutral, peer-reviewed sources.

· Responsible Engagement:

Students should engage with AI in a respectful and responsible manner and avoid using offensive language, discriminatory remarks, or engaging in any form of harassment or inappropriate behavior. Students should also uphold the standards of respectful communication in addressing both AI and fellow classmates.

· Compliance with South Plains College Policies:

Policies regarding the appropriate use of AI in South Plains College courses are set by instructional departments and individual instructors. Appropriate use of AI may range from strict prohibition to assignments they may require the use of AI. Misusing or violating the guidelines outlined in this syllabus warning may result in disciplinary action, including academic penalties. Students are expected to familiarize themselves with the specific course policies regarding the use of AI and adhere to them throughout the semester.

Remember, AI can be a tool to support your learning in certain courses and assignments, but it cannot replace the critical thinking, creativity, and independent work that are integral to your overall academic growth.
