#### **COURSE DESCRIPTION**

Selected composers and compositions will be studied through an interpretation of their historical, functional, and cultural significance. This course satisfies the core curriculum requirement for Visual or Performing Arts.

#### **LEARNING OUTCOMES**

1. Identify musical works and elements in a variety of styles.
2. Analyze the elements and structure of music using appropriate terminology.
3. Critically evaluate the influence of social, political, technological, and/or cultural ideas on music.
4. Articulate the significance of music as an art form within historical, cultural and social contexts.

#### **REQUIRED MATERIALS**

Textbook: **The Enjoyment of Music**, Essential Listening Edition, 4<sup>th</sup> ed. By Forney/Dell'Antonio; note taking materials

#### **CORE OBJECTIVE STUDENT LEARNING OUTCOMES:**

This course is included in the Creative Arts foundation component area, as described by the Texas Higher Education Coordinating Board, and will reinforce the Core Objective student learning outcomes of Communication Skills, Critical Thinking, Teamwork, and Social Responsibility. Students will demonstrate effective written, oral, and visual communication. Students will be encouraged to thoroughly assess and investigate problems with the goal of full comprehension. Students will be encouraged to function as part of a team. Students will demonstrate intercultural knowledge.

#### **COURSE ORGANIZATION**

This course will be offered as a "Flex" option. This means that there will be some face-to-face instruction with online instruction provided to supplement and enhance learning. This course can take on many different formats. Some include:

1. Lecture online with lab components face-to-face
2. Flipped classroom with online lecture delivery and face-to-face discussion
3. Face-to-face lecture delivery with online discussion / course supplements / online testing
4. Some face-to-face instruction supplemented with online instruction

There may need to be changes as the semester goes on, so flexibility will be the key to our success. I will do my best to communicate changes to you as soon as they arise.

### **GRADING POLICY**

The final grade average will be based on exam grades (50%), written assignments (40%), and a concert attendance project (10%).

### **EXAMS**

There will be five exams covering six historical periods.

1. Middle Ages: 400-1400/Renaissance: 1400-1600 (& Fundamental terms)
2. Baroque: 1600-1750
3. Classical: 1750-1825
4. Romantic: 1825-1900
5. Modern: 1900-Present

Each exam is worth 10% of the final grade average. Exam materials will be drawn from class lectures, text readings, and listening example discussions. Exam dates will be announced. Exams will be taken on Blackboard (online) and **must** be completed during the announced exam dates. Failure to complete the exams during the announced exam dates will result in a grade of zero for each. It is the student's responsibility to access a reliable computer and internet connection. "Computer problems" will not be an acceptable excuse for failing to submit an exam prior to the deadline.

### **WRITTEN ASSIGNMENTS**

You will have five written assignments to complete that correlate with the end of each historical section. The assignments are designed to make you think and express your opinion about a particular topic. You will be given a prompt and you will need to submit a two page, typed, double-spaced, 12-point font paper. You will be evaluated on your ability to provide thoughtful and convincing arguments for your opinion.

### **CONCERT ATTENDANCE PROJECT**

This project is worth 10% of the final average. The student will **fully** watch one of the concerts listed and submit a two page, typed, double-spaced, 12-point font paper. The content of the paper should be focused on evaluating and reacting to the experience and the music, not a listing of compositions and performers. **Students must choose from a list of approved concerts provided by the instructor.**

**Projects which do not follow the above requirements will not receive credit.**

### **CLASS ATTENDANCE/PARTICIPATION**

Students are expected to participate in class. There currently is not an official South Plains College Fall 2020 attendance policy. However, you will be expected to participate in required discussions and assignments. If a student hasn't participated in any form for a

minimum of three weeks without any communication and is earning an “F” in the class, then they will be administratively withdrawn from the class. Students will attend the section in which they are registered if they choose to come to class for the lecture. Students may choose to attend the class (**the number of students attending the lecture will be limited and you must wear a mask and not have any flu/Covid symptoms**), view the Collaborate lecture, or watch the recorded lecture posted on Blackboard at a later time. If you have any questions or concerns about how you will “attend” class, please let me know. These circumstances will require patience and understanding by everyone involved.
