Course Description

Design and operation of fire detection and alarm systems, heat and smoke control systems, special protection and sprinkler systems, water supply for fire protection, and portable fire extinguishers. This course meets Fire and Emergency Services Higher Education (FESHE) Model Curriculum core requirements.


This course provides information relating to the features of design and operation of fire alarm systems, water-based fire suppression systems, special hazard fire suppression systems, water supply for fire protection and portable fire extinguishers.

Course Outcomes

At the end of this course, students will be able to identify fire detection and alarm systems, heat and smoke control systems, special protection and sprinkler systems, water supply for fire protection, and portable fire extinguishers; identify the applications of fire detection, alarm, and extinguishing systems; and explain the operation of fire detection, alarm and extinguishing systems. Additional course outcomes include:

- Explain the benefits of fire protection systems in various types of structures.
- Describe the basic elements of a public water supply system including sources, distribution networks, piping and hydrants.
- Explain why water is a commonly used extinguishing agent.
- Identify the different types and components of sprinkler, standpipe, and foam systems.
- Review residential and commercial sprinkler legislation.
- Identify the different types of non-water-based fire suppression systems.
- Explain the basic components of a fire alarm system.
- Identify the different types of detectors and explain how they detect fire.
- Describe the hazards of smoke and list the four factors that can influence smoke movement in a building.

- Discuss the appropriate application of fire protection systems.
- Explain the operation and appropriate application for the different types of portable fire protection systems.

GENERAL SAFETY ON CAMPUS

SOCIAL MEDIA POLICY

Students wanting to post pictures or information on their class activities during class time is allowed if the instructor or academy coordinator approves it. COVID 19

If you are experiencing any of the following symptoms, please do not attend class and either seek medical attention or test for COVID-19:

- Cough, shortness of breath, difficulty breathing
- Fever or chills
- Muscles or body aches
- Vomiting or diarrhea
- New loss of taste and smell

A home test is sufficient but students must submit a photo of the positive result. The date of test must be written on the test result and an ID included in the photo. If tested elsewhere (clinic, pharmacy, etc.), please submit a copy of the doctor's note or email notification. Results may be emailed to DeEtte Edens, BSN, RN at dedens@southplainscollege.edu.

A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication.

Students must communicate with DeEtte Edens, BSN, RN prior to their return date if still symptomatic at the end of the 5-day isolation.

FLEXIBILITY
