- Produce hairstyles using elements of good hair design.
- Perform cosmetology services using professionalism.
- Demonstrate the competencies desired in a cosmetology workplace.

CSME 2337 students will demonstrate competencies in the following tasks;

- Demonstrate the competencies desired in a cosmetology workplace.
- Exhibit the use of information and tools related to the artistry of hair.
- Perform cosmetology services using professionalism.
- Produce hairstyles using elements of good hair design.
- Create hairstyles using elements of correct hair design (proportion and balance).
- In order to receive a passing grade for this course, a student must complete 90% of the competencies. A student who chooses to voluntarily withdraw from this course will receive a **W**; a student who does not meet 90% of all of the competencies will receive an **F**.
