#### SOUTH PLAINS COLLEGE IMPROVES EACH STUDENT'S LIFE

<u>Course Description</u>: This course is the study of the principles and operation of single and three-phase motors and transformers. Topics included here are transformer banking, power factor correction, and protective devices.

Course Learning Outcomes: The goals/objectives of this course are:

The student will match the type of single-phase motor with its type of operation. Compare the operating characteristics of three types of three-phase motors. Explain the advantages of Wye and Delta connections in motor and transit applications. Size overcurrent, short circuit, and ground fault protection devices. Utilize nameplate information.

A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication.
