GENERAL COURSE INFORMATION:

<u>Course Description</u>: A study of the theoretical and practical operation of electric utility distribution systems. Topics include customer service voltages, capacitors, and coordination of protection equipment.

<u>Course Learning Outcomes</u>: The goals/objectives of this course are: Explain basic single-phase electrical systems. Explain three phase electrical system. Understand utility service operations. Learn safe working procedures around utility operations.

<u>Course Competencies</u>: Upon successful completion of this course, each student will have demonstrated through comprehensive examinations, with a score of 70% or better, a competent understanding of: Single and three-phase operating systems. Safe work practices. Line complaint and troubleshooting.

<u>Academic Integrity</u>: The attempt of any student to present as his or her own work which he or she has not honestly performed is regarded by the faculty and administration as a most serious offense and renders the offender liable to serious consequences, possibly suspension. If you have a question as to whether you may work with other students on any assignment, ASK YOUR INSTRUCTOR.

It is the student's responsibility to complete work missed within a reasonable period of time as determined by the instructor.

A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of feverreducing medication.

Students must communicate with DeEtte Edens, BSN, RN prior to their return date if still symptomatic at the end of the 5-day isolation.
