<u>Course Description</u>: This course is designed for basic underground electrical utility system fault locators and troubleshooters on Underground Distribution systems. Students will study and practice basic Underground Distribution troubleshooting and fault locating using recommended manufacturer's procedures, and will follow all safe work procedures within the OSHA Standard and American Public Power Association Safety Manual.

<u>Course Learning Outcomes</u>: In this course students will isolate, de-energize, test and ground Underground Distribution systems. Using fault locating equipment will locate and repair faulted cable. Students will identify and use all personal protective equipment and cover-up when working on energized equipment. Students will understand and meet all OSHA safety procedures when working in or around open trenches when exposing Underground Distribution cable. Students will identify and understand all systematic switching procedures to isolate faulted cable.

<u>Academic Integrity:</u> The attempt of any student to present as his or her own work which he or she has not honestly performed is regarded by the faculty and administration as a most serious offense and renders the offender liable to serious consequences, possibly suspension. If you have a question as to whether you may work with other students on any assignment, ASK YOUR INSTRUCTOR.

<u>Assignment Policy:</u> All required work must be turned in on time in order that the student may benefit from the corrections and study for future examinations. Assigned outside work is DUE ON THE CLASS PERIOD ASSIGNED. The instructor has sole discretion as to whether late work is acceptable.

The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus. **Students with four (4) or more absences MUST contact their instructor.**

It is the student's responsibility to complete work missed within a reasonable period of time as determined by the instructor.

A home test is sufficient but students must submit a photo of the positive result. The date of test must be written on the test result and an ID included in the photo. If tested elsewhere (clinic, pharmacy, etc.), please submit a copy of the doctor's note or email notification. Results may be emailed to DeEtte Edens, BSN, RN at dedens@southplainscollege.edu.

A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication.

Students must communicate with DeEtte Edens, BSN, RN prior to their return date if still symptomatic at the end of the 5-day isolation.
