<u>Course Description</u>: This course provides a study of power outages and voltage complaints on distribution systems. Includes lockout-tagout procedures, safety grounds, backfeed, induced voltage, causes of outages, and analyzing voltage complaints.

<u>Course Learning Outcomes</u>: In this course students will describe causes of power outages; illustrate lockout-tagout procedures; and describe step and touch potentials. Describe backfeed and induced voltages; and calculate service size from customer load. Explain causes of power outages and voltage problems; explain grounding procedures; and all relevant safety rules and procedures.
