Course Description:

A survey of the social, political, economic, cultural, and intellectual history of the United States from the Civil War/Reconstruction era to the present. United States History II examines industrialization, immigration, world wars, the Great Depression, Cold War and post-Cold War eras. Themes that may be addressed in United States History II include American culture, religion, civil and human rights, technological change, economic change, immigration and migration, urbanization and suburbanization, the expansion of the federal government, and the study of U.S. foreign policy.

Prerequisites: TSI compliance in Reading

Credit: 3 Lecture, 0 Lab

Required Textbooks: *OpenStax US History* and *A Treasury of Great American Scandals: Tantalizing True Tales of Historic Misbehavior by the Founding Fathers and Others Who Let Freedom Swing*

Core Curriculum Objectives:

1. **Critical thinking:** demonstrates creative thinking, innovation, inquiry, analysis, evaluation, and synthesis of information.
2. **Demonstrates communication:** demonstrates communication through effective development, interpretation and expression of ideas through written, oral and visual communication.
3. **Demonstrates social responsibility:** demonstrates social responsibility through intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities.
4. **Demonstrates personal responsibility:** demonstrates the ability to connect choices, actions, and consequences to ethical decision-making.

Learning Outcomes: Upon successful completion of this course, students should be familiar with the evolution of the nation and its role in the world from the mid-nineteenth century to the early twenty-first century. This would include the following themes:

- American culture
- religion
- civil and human rights
- technological change
- economic change
- immigration and migration
- urbanization and suburbanization
- the expansion of the federal government
- the study of U.S. foreign policy

Learning Outcomes: Upon successful completion of this course, students will:

- Create an argument through the use of historical evidence.
- Analyze and interpret primary and secondary sources.
- Analyze the effects of historical, social, political, economic, cultural, and global forces on this period of United States history.

Course Evaluation: See the instructor's course information sheet for specific items used in evaluating student performance.

Attendance Policy: Students are expected to attend all classes in order to be successful in a course. Whenever absences become excessive and in the instructor's opinion, minimum course objectives cannot be met due to absences, the student will be withdrawn from the course. Each instructor will have additional information about attendance on his/her course information sheet.

**Students who enroll in a course but have "Never Logged In" by the official census date, as reported by the faculty member, will be administratively dropped by the Office of Admissions and Records. A student who does not meet the attendance requirements of a class as stated in the course syllabus and does not officially withdraw from that course by the official census date of the semester, may be administratively withdrawn from that course and receive a grade of "X" or "F" as determined by the instructor. Instructors are responsible for clearly stating their administrative drop policy in the course syllabus, and it is the student's responsibility to be aware of that policy.

It is the student's responsibility to verify administrative drops for incomplete coursework through MySPC using his or her student online account. If it is determined that a student is awarded financial aid for a class or classes in which the student never attended or participated, the financial aid award will be adjusted in accordance with the classes in which the student did attend/participate and the student will owe any balance resulting from the adjustment.

3. Using an unauthorized source of information (notes, textbook, text messaging, internet, apps) during an examination, quiz, or homework assignment;
4. Entering an office or building to obtain unfair advantage;
5. Taking an examination for another;
6. Altering grade records;
7. Copying another's work during an examination or on a homework assignment;
8. Rewriting another student's work in Peer Editing so that the writing is no longer the original student's;
9. Taking pictures of a test, test answers, or someone else's paper.

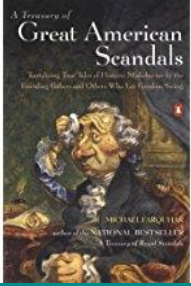

 1. We will have sixteen (16) chapter quizzes from the *OpenStax* book.
 2. Chapter quizzes are multiple choice and/or identifications.*
 3. The quizzes will be timed.
 4. Quizzes cannot be made up. **If you do not take the quiz by the due date and time you will make a zero on that quiz.**
 5. Each quiz is worth 100 points.
 6. **You will have three attempts on each quiz (excluding identifications).** **Your highest grade will**

count.

7. Your lowest three (3) chapter quiz grades will be dropped—excluding the quizzes with identifications. Quizzes with identifications can NOT be dropped.*
8. The remaining quizzes added together will be worth a total of up to 1100 points.

* Two quizzes will have a written portion (identifications). An identification or id is a grammatically correct** answer that includes the who, what, where, when, why, what happened, and why the topic is important in US History. There is an example of an identification in Blackboard. The two quizzes with identifications will have two sections: one with multiple choice questions (with three attempts) and one with the identifications (one attempt) for a total of 100 points each. These quizzes can NOT be dropped and will appear in a separate total column in the Grade Book (OSWrite-Total).

**SPC Policy regarding “standard English”: All written assignments should be presented using the conventions of Standard Written English. South Plains College requires all students to become proficient in "academic English," a form of English that is typically used in academic, professional, and business contexts. While slang, regional idioms, and informal kinds of self-expression are appropriate in some contexts, they are out of place in academic writing. Writing instructors and professors in courses across the campus expect all students to demonstrate proficiency in using the conventions of academic English in their written work.

D. Reading Quizzes-300 points:

1. You will have eight multiple choice quizzes over readings from *A Treasury of Great American Scandals*.
2. Reading quizzes are all multiple choice.
3. The quizzes will be timed.
4. Quizzes cannot be made up. **If you do not take the quiz by the due date and time you will make a zero on that quiz.**
5. Each quiz is worth 50 points.
6. **You will have two attempts on each quiz. Your highest grade will count.**
7. Your lowest two (2) reading quiz grades will be dropped.
8. The remaining quizzes added together will be worth a total of up to 300 points.

E. Comprehensive Final Exam—300 points:

1. The final exam will be all multiple choice, with questions coming from OpenStax chapters 16-31.
2. The final will be timed.
3. The final cannot be made up. **If you do not take the final by the due date and time you will make a zero.**
4. You will have two attempts. Your highest grade will count.

F. Social Responsibility Paper—100 points (more information in Blackboard)

Your work must be turned in on schedule to receive credit – nothing can be submitted for credit after the due date and time have expired. There are no exceptions to this provision. Please note that all ASSIGNMENTS/ASSESSMENTS must be submitted by 11:59PM Central Time to receive credit.

***** DO NOT ASK ME TO RESET THE QUIZZES OR THE FINAL EXAM.**

***** DO NOT ASK ME TO CHANGE THE DUE DATES.**

What I do for one student, I must do for all students. I can't play favorites or give one student an advantage over another student.

All assessments are available on the first day of class. I allow you to work ahead of schedule (and you should work ahead just in case a loved one dies or you get sick.)

I drop your lowest quiz grades, so it doesn't kill your grade to miss a quiz.

You have more than one attempt on every quiz (other than written portions). You may use all the attempts for whatever reason--technological problems, low grades, whatever. I allow more than one attempt so that if you have technological problems, you will have another chance to complete the quiz. If you have computer or internet problems on the first attempt, check with IT at 806-716-2180 or blackboard@southplainscollege.edu before beginning the next attempt. Please keep in mind that IT help is NOT available 24/7. If you do have problems, you might want to consider using a different computer or internet connection on the second attempt. **The only way I will reset an attempt on ANY assignment or assessment is if there is a problem with Blackboard that is documented by the SPC IT department. If there is a problem with Blackboard or the SPC server I will be notified. When Blackboard becomes available again, I will reset quiz due dates so that you can take quizzes affected by the outage.**

I have the Blackboard Grade Book (My Grades) set up so that it keeps a running total of your grades AFTER the lowest quizzes have been dropped.

The first column is your overall semester grade. It is the sum of
column 2—OS-Total (with the lowest quizzes dropped),
column 3—OSWrite Total
column 4---Read-Total (with the lowest quizzes dropped),
column 5—Final Exam
column 6---the Statement of Personal Responsibility
column 7---syllabus quiz
column 8---Social Responsibility Paper

After you take your first OS quiz, you should have a grade in OS-1 and a grade for personal responsibility and the syllabus quiz and a grade in the Total column (depending on what grade you made on the statement of responsibility and syllabus quiz). You won't see a grade in OS-total until you take the fourth quiz (and have three to drop). You won't see a grade in the Read-Total column until you take the third reading quiz (and have two to drop).

Every time you submit an OS or reading quiz, Blackboard will recalculate your grades to determine your lowest quiz grades and drop them. The lowest grades can change depending on your grades.

You may experience a little glitch in Blackboard. Every assignment is due (must be submitted) by 11:59 PM. Sometimes when a student submits a quiz at 11:59 PM, the program will mark it as late and flag it. I always check quizzes that are flagged. If your assignment is time-stamped 11:59PM, you will get credit. If it is time-stamped 12:00 you won't get credit.

“It is the aim of the faculty of South Plains College to foster a spirit of complete honesty and a high standard of integrity. Complete honesty is required of the student in the presentation of any and all phases of course work. This applies to quizzes of whatever length, as well as to final examinations, to daily reports and to term papers.

Plagiarism: Offering the work of another as one’s own, without proper acknowledgment, is plagiarism; therefore, any student who fails to give credit for quotations or essentially identifiable expression of material taken from books, Internet resources, encyclopedias, magazines and other reference works, or from the themes, reports or other writings of a fellow student, is guilty of plagiarism.”

Students found guilty of cheating or plagiarism will earn a zero on the assignment and an F in the class. It doesn’t matter if you “borrow” three words or a paragraph, fail to cite the source or cite the wrong source, any cheating or plagiarism will result in your being dropped from the class with an F. Academic dishonesty occurs when you share course content, assignments, or answers when sharing course content, assignments, items, or answers with anyone including current or future students and posting course content on websites such as Quizlet, Course Hero, or similar sites. The information and assignments in this course are proprietary and are not yours to share. READ THE ACADEMIC INTEGRITY/PLAGIARISM HANDOUT IN BLACKBOARD BEFORE ATTEMPTING THE WRITTEN PORTION OF QUIZZES.

The two main reasons people fail this class are (a) failing to complete assessments by the due date and time (b) plagiarism.

Basic information on writing:

1. What you submit must be in your own words. Paraphrase! Do not copy the sentence structure or words of the sources you use.
2. I have a copy of the textbook and I know what it says.
3. If I don't remember exactly what it says, I can look it up.
4. Oftentimes there is not enough information in the textbook to answer fully the identification assigned so that you must use a source other than the textbook.
5. If you include information that is not in the textbook, I know that the information came from a source other than the textbook. If you don't cite the source, you are guilty of plagiarism.
6. Even what you learned in another class must be corroborated and you must cite the source.
7. Things that you think you know must be corroborated and you must cite the source. "Common knowledge" or "prior knowledge" are not legitimate excuses for failing to cite sources. If the information is not ***VERY COMMON KNOWLEDGE*** (such as the capital of France is Paris), then you must provide corroborating evidence and cite the source.
8. **IF THE INFORMATION IS NOT YOUR PERSONAL THOUGHT, CONCLUSION, HYPOTHESIS, OR DISCOVERY, THEN IT MUST BE CITED.**
9. I have the internet. I can copy and paste your submission into Google and can usually find the source you used.
10. Do not use direct (word for word) quotations in my class. If you do use direct quotations, you will make a zero on the entire assignment.
11. It is better to cite everything than to cite nothing.
12. **I am serious that if you plagiarize, you will make a zero on the entire assignment and then you will be dropped from the class, immediately and without warning, with an F and reported to the appropriate deans and the vice president. If you fail to cite your sources, whether deliberately or inadvertently, you will still be found responsible for the act of plagiarism. Ignorance of academic regulations or the excuse of sloppy or rushed work do not constitute an acceptable defense against the charge of plagiarism.**
13. You must use a reliable source. **Wikipedia is Not a Reliable Academic Source. DO NOT USE WIKIPEDIA OR OTHER ENCYCLOPEDIA TYPE SOURCES.** If you use an unreliable source you will make a zero on the entire assignment.

14. Cite your sources using parenthetical references. Place the reference immediately following the borrowed material (Bogener, "Information about Plagiarism," page 6.). For internet sources all I need is the COMPLETE URL ADDRESS from the page where you get your information. URL addresses frequently
