Whenever absences become excessive and in the instructor's opinion, minimum course objectives cannot be met due to absences, the instructor may recommend that the student withdraw from the course.

SECTION I: Course Description & Objective

This course explores the origin and development of the Texas constitution, structure and powers of state and local government, federalism and inter-governmental relations, political participation, the election process, public policy, and the political culture of Texas.

Course Objectives addressed:

1. **Critical thinking:** to include creative thinking, innovation, inquiry, and analysis, evaluation, and synthesis of information.
2. **Communication:** to include effective development, interpretation and expression of ideas through written, oral and visual communication.
3. **Social responsibility:** to include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities.
4. **Personal responsibility:** to include the ability to connect choices, actions, and consequences to ethical decision-making.

In terms of the objectives of the course, students should be able to do the following upon completion of this course:

1. Explain the origin and development of the Texas Constitution.

SECTION IV: Description of Assignments

1. (3) Exams: 300 points total (100 points per exam)

There are *two* regular exams in this course and *one* final exam, and tests will be cumulative in format. **Study guides will be made available.** Exam format will range between a mix of true/false, multiple-choice type questions, and fill-in-the blank type questions. Each exam will be no longer than 50 questions and taken largely from lectures and any additional readings required for potential material on each exam. You will need a scantron and pencil to complete the test and these are your responsibility to bring with you on test days.

2. (3) Homework Assignments: 210 points total

There are 3 homework assignments for this course, and each is meant to challenge you into critically thinking about current events within the political arena and the role of government and political parties in shaping this—including assessing current political dynamics. Two of the assignments will be in-class, and one will be an at writing assignment. These assignments are available via blackboard for one week. The last assignment will be open from **Monday at 8am** and is due the following **Monday at 11:59pm.**

3. (4) In-Class Activities: 160 points total (40 points each)

There will also be three in-class activities to reinforce various concepts throughout the course. Just like the pop-quizzes, these activities will occur at a time and date of my choosing and none are meant to be time consuming, just to challenge you into critically thinking about politics.

4. Attendance & Participation: 60 points total

Attendance is required in this course. I will take roll at the beginning of each class and assign a participation grade at the end of the semester. This grade will be a mix of your performance on attending lectures, class discussions, and overall class participation. These should be free, easy points for everyone! You will lose 3 points from participation score for each class you miss.

*Extra Credit

I do not offer extra credit to individuals. When I do offer extra credit, the opportunity is offered to all class members equally, provided they have attended the class where the credit is offered, or have engaged in proper due diligence to find out what extra credit was offered (assuming the extra credit is not already past due). There are no make-ups offered for extra credit. *** If you want to take advantage of potential extra credit, come to class. ***

SECTION V: Course Policies

- A. CIVILITY & CRITICAL THINKING.** In this course, civility and critical thinking are both required and go hand in hand. **I will not tolerate instances of incivility**; nor will I tolerate uninformed opinions masked as critical thinking and facts. We are living in an unprecedented political time where civility in public discourse is eroding, so it is understandable that as individuals our emotions and passions are elevated as a result. ***Even still, I expect civility among my students.*** All discussions in class must be polite and professional. In any classroom situation that includes discussion and critical thinking in politics, there are bound to be many differing viewpoints. I strongly encourage debate in this course because it helps facilitate learning. You should not hesitate to raise your hand and challenge the arguments or concepts presented by the instructor or other students. However, as you know, shouting, irrationality, and even apathy are characteristics that are not conducive to effective learning. Students who disrupt this classroom mission by rude, sarcastic, threatening, abusive or obscene language and/or behavior will be subject to appropriate sanctions according to university policy. Likewise, faculty members are expected to maintain the highest standards of professionalism in all interactions with all constituents of the university.
- B. I encourage you to utilize my available office hours.** I am here to help you understand government and politics, and I strongly encourage you to take advantage of my office hours. If designated office hours are inconvenient, please feel free to arrange a meeting with me at another time at your discretion.
- C. Please read the syllabus thoroughly.** You will hear this often, and it will get old, but do it. If you email me a question that can be *clearly* answered by simply reading the syllabus (such as, “I was sick. Can I take a make-up?”), you will get an email from me stating “see syllabus”. If you don’t understand the syllabus, please ask me after class or try during available office hours, or call me on the phone, and I will be happy to answer your questions.

- D. *NO CELL PHONE AND/OR HEADPHONE USE DURING CLASS. PUT THEM AWAY.** You are not to use personal cell phones and/or sit in class with your headphones on. It's just rude so seriously, use your own time for that. This is also something you will hear often and that will get old, so just don't be that person. However, please be advised that depending on my access to the internet over the weekend, I may not be able to respond until the next business day (or slightly longer during holidays). If you email me at 5:00 PM on Friday, I may be unable to respond until Monday. *I will only accept emails from South Plains College email accounts.*
