Whenever absences become excessive and in the instructor's opinion, minimum course objectives cannot be met due to absences, the instructor may recommend that the student withdraw from the course.

SECTION I: Course Description & Objective

This course explores the origin and development of the Texas constitution, structure and powers of state and local government, federalism and inter-governmental relations, political participation, the election process, public policy, and the political culture of Texas.

Course Objectives addressed:

1. **Critical thinking:** to include creative thinking, innovation, inquiry, and analysis, evaluation, and synthesis of information.
2. **Communication:** to include effective development, interpretation and expression of ideas through written, oral and visual communication.
3. **Social responsibility:** to include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities.
4. **Personal responsibility:** to include the ability to connect choices, actions, and consequences to ethical decision-making.

In terms of the objectives of the course, students should be able to do the following upon completion of this course:

1. Explain the origin and development of the Texas Constitution.

SECTION IV: Description of Assignments

1. (2) Exams: 240 points total (120 points per exam)

There is **one midterm exam** in this course and **one final exam**. Tests will be cumulative in format. Exam format will range between a mix of true/false and multiple-choice type questions, as well as the possibility for fill-in-the blank and/or short essay answers. Each exam will be no longer than 60 questions, is taken largely from lectures, and study guides will be made available. **Exams will be honor-locked, meaning your browser will lock down and I record your screen. You may use notes that you have taken yourself or from the study guide provided.**

2. (2) Homework Assignments: 200 points total

There are two homework assignments for this course online via Blackboard and each is meant to challenge you into critically thinking about current events within the political arena and the role of government and political parties in shaping this—including assessing current political dynamics. The first assignment is a discussion board about school vouchers where you must respond to the prompts as well as respond to at least two of your peers' responses. The second assignment is a political typology quiz where you will answer a series of questions, respond to a couple of prompts and share your results with me, and ONLY me. The last assignment is a small writing exercise on the need for consensus in the political system and discussion board where you must respond to at least two of your peers' responses. **The use of AI, in any form, to complete this—or any—assignment will result in an automatic zero.**

3. (6) Quizzes: 210 points total (35 points per quiz)

There will be six quizzes for this course and these will be given on a week of my choosing, but you will have ample notice. Quizzes will be a mix of essay and multiple-choice type questions. Your quizzes will be administered via Blackboard, will be open book and note, and will be due by **midnight Friday** the week it is assigned. I will make an announcement in class on the week of and send an announcement via Blackboard.

*Extra Credit

I do not offer extra credit in this course to any individuals, except for extreme and unforeseen circumstances. These are made on a case-by-case basis. There are no make-ups offered for extra credit.

SECTION V: Course Policies

A. CIVILITY & CRITICAL THINKING. In this course, civility and critical thinking are both required and go hand in hand. **I will not tolerate instances of incivility;** nor will I tolerate uninformed opinions masked as critical thinking and facts. We are living in an unprecedented political time where civility in public discourse is eroding, so it is understandable that as individuals our emotions and passions are elevated as a result. **Even still, I expect civility among my students.** All discussions must be polite and professional. In any online situation that includes discussion and critical thinking in politics, there are bound to be many differing viewpoints. I strongly encourage debate in this course because it helps facilitate learning. You should not hesitate to challenge the arguments or concepts presented by the instructor or other students. However, as you know, inappropriate behavior, irrationality, and even apathy are characteristics that are not conducive to effective learning. Students who disrupt this class mission by rude, sarcastic, threatening, abusive or obscene language and/or behavior will be subject to appropriate sanctions according to SPC policy. Likewise, faculty members are expected to maintain the highest standards of professionalism in all interactions with all constituents of SPC, and you will ALWAYS get this from me, but mostly I foster a non-partisan teaching approach to the presentation of course material. You are free to be partisan, by all means, but I am not and will not be. It is my gift to you!

- B. Please read the syllabus thoroughly.** You will hear this often, and it will get old, but do it. If you email me a question that can be *clearly* answered by simply reading the syllabus (such as, “I was sick. Can I take a make-up?”), you will get an email from me stating “see syllabus”. If you don’t understand the syllabus, please ask me after class or try during available office hours, or call me on the phone, and I will be happy to answer your questions.
- C. Email policies. CHECK IT!** That I didn’t see your email, will not be an excuse in this course. We are all busy, but I will always put forth my best effort to make myself available. Although I try to check my email at least once a day, I do not always check emails at frequent intervals during the day.
