**Course Descriptions and Objectives**

This course is a study of the functions performed in the American system of state governments, with special reference to the development of governance in Texas and its Constitutions. This course satisfies the Legislative requirements for teacher certification.

*Credits:* 3 Lecture Hours

*Prerequisites:* TSI compliance in Reading

**Course Objective**

Government 2306, as taught at South Plains College, is a reading intensive course designed to acquaint the learner with the origin and development of the Texas Constitution, structure and powers of state and local government, federalism and intergovernmental relations, political participation, the election process, public policy, and the political culture of Texas. **Course Learning Outcomes and Assessments**

Student Learning Outcomes

Students who have completed this course will be expected to:

1. Explain the origin and development of the Texas Constitution
2. Demonstrate an understanding of state and local political systems and their relationship with the federal government
3. Describe separation of powers and checks and balances in both theory and practice in Texas
4. Demonstrate knowledge of the legislative, executive, and judicial branches of Texas Government
5. Evaluate the role of public opinion, interest groups and political parties in Texas
6. Analyze state and local elections processes
7. Describe the rights and responsibilities of citizens
8. Analyze issues, policies and political culture in Texas

**Fundamental Component Areas (FCAs)**

Students will be expected to perform satisfactorily in four FCAs.

1. Critical Thinking Skills – to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information by:
  - a. Generating and communicating ideas by combining, changing, or reapplying existing information,
  - b. Gathering and assessing information relevant to a question,
  - c. Analyzing, evaluating, and synthesizing information.
2. Communication – to include effective development, interpretation and expression of ideas through written, oral or visual communication by: developing, interpreting, and expressing ideas through written, oral, or visual communication.

3. Social Responsibility Skills – to include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively I regional, national, and global communities by:
  - a. Demonstrating intercultural competence,
  - b. Identifying civic responsibility,
  - c. Engaging in regional, national, and global communities.
4. Personal Responsibility –to include the ability to connect choices, action, and consequences to ethical decision-making by:
  - a. Reading, understanding and affirming agreement and acceptance of principles, guidelines and requirements set forth in the “Statement of Personal Responsibility of Students” (Attached)
  - b. Evaluating choices and actions and relating consequences to personal decision-making
  - c. Accepting personal responsibility for decisions and actions taken or not taken

There are some important things to know about this class. Besides learning the basics of Texas Government, students will be encouraged to think critically. To succeed in this class, then, you must be actively engaged and participate in discussion concerning the material of the course. It is also important to note that in order to help prepare you for the professional environment that many of you will enter upon graduating from college; we will conduct class in a professional manner. By enrolling in this course, you are committing to attending class and being punctual, being prepared and participating, and communicating with each other and myself in a professional and respectful manner.

### **Grading Guidelines:**

***Midterm Exams (75% or 150 total points: three at 25% or 50 points each)***

Exams are the primary means by which I track your progress throughout the class. There will be three exams, each worth 25% or 50 points towards of the final grade. The ***three exams are not cumulative.*** However, anything covered in class lecture or discussion is fair game for exams, as are any potential assigned readings. Make-up exams will only be permitted with an official excused absence document

from South Plains College, a physician's office, or likewise. Any make-up exams must be taken on the reserved make-up exam date determined by the instructor. ***Writing Assignments (25% or 50 points total – 25 points per assignment)***

The writing component of the course is worth 25% or 50 points toward your total grade. There will be two short writing assignments, each worth 25 points. Details regarding the writing assignments will be provided in a future handout. If you believe that an error has been made in calculating your final grade, it's your responsibility to provide me with documentation demonstrating that a calculation error has been made.

***Late Work***

Any potential assignments, potential extra credit exercises, and the course essay must be completed and turned in by the accompanying due date set by the instructor. Due dates will be provided well in advance. Items with due dates must be submitted at the beginning of class for the submission to be considered for full credit. Turning in assignments after the agreed upon due date is circumstantial and may be accepted at the discretion of the instructor...but will be assessed a penalty. For each day a writing assignment is late three points will be deducted from the overall writing assignment grade (of 25 total points). This is equivalent to more than a full letter grade deduction on the assignment!

***Extra Credit:***

There may be opportunities to receive extra-credit points throughout the semester, therefore no major extra credit opportunities (i.e. additional papers, essays or special assignments...) will be offered to or accepted from students at the end of the semester.

***Attendance***

It is important that you learn this material, and class attendance is strongly associated with such learning. Attendance is not mandatory in that it is not a recorded component of your grade. Roll, however, will be taken intermittently for SPC purposes (i.e. roster verification). This doesn't imply that attendance should be taken lightly. Repeated absences will be detrimental to your final course grade, in that you will miss important material presented in class that is supplemental to any assigned course materials. Tardiness and leaving class early is also disrespectful to your colleagues and disruptive to lectures. If for any reason you are disruptive to those around you and continually upset the flow of lecture, I reserve the right to ask you to remove yourself from class. Please be respectful to those around you. The only absences that I will excuse are official university events sponsored by official university organizations. You are responsible for all work assigned for any class regardless of your attendance. Ask your classmates for notes and other important information you miss if absent. Any student who intends to observe a religious holy day should make that intention known to the instructor prior to the absence. A student who is absent from classes for the observance of a religious holy day shall be allowed to take an exam or complete an assignment from which the student is excused.

If a student accumulates **FOUR unexcused absences**, it will result in the student being dropped from the course, while receiving a final letter grade of an "F".
