Course Description:

A survey of the political, social, economic, cultural, and intellectual history of Texas from the pre-Columbian era to the present. Themes that may be addressed in Texas History include Spanish colonization and Spanish Texas; Mexican Texas; the Republic of Texas; statehood and secession; oil, industrialization, and urbanization; civil rights; and modern Texas.

Prerequisites: TSI compliance in Reading

Credit: 3 Lecture, 0 Lab

Required Textbooks: *Beyond Myths and Legends*, 5th edition and *Texas Voices: Documents and Biographical Sketches*, 5th edition

Attendance Policy: Students are expected to attend all classes in order to be successful in a course. 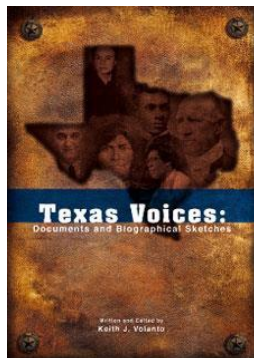

Classroom attendance is a fundamental student obligation and a requirement for successful course completion. Students are ultimately responsible for everything said or distributed in class or in Blackboard.

(a) Class begins and ends punctually according to the clock in the classroom.

(b) Roll will be recorded by sign in sheet. **The sign in sheet will be available until the scheduled class starting time. Your signature on the roll sheet is the official record of your attendance. If you fail to sign the roll sheet, you will be counted absent.**

(c) Being late for class is unacceptable for any reason. Tardiness is rude, disrespectful, and disruptive to the classroom setting. **If you arrive AFTER the prescribed time for class to begin, you will be counted absent.**

(d) There are no excused or unexcused absences.

(e) You should plan to be in class for the entire period. Anyone who cannot comply with this time frame needs to seek an alternative class since deviations from this policy will not be tolerated. A student who leaves class even momentarily will be marked absent for that class period even if he/she was present for the majority of the time at the instructor's discretion.

(f) Students will be allowed to miss four (4) class meetings. If a student misses a fifth class he/she will be administratively dropped with an F. Additional absences will not be allowed because of severe illness or

bereavement.

(f) If more than four absences accumulate after the official administrative drop date passes, then the student's final grade will be lowered by one letter grade for each absence over the number allowed (4).

(g) If you must miss class, PLEASE DO NOT CALL or MESSAGE ME. *Be sure to get the notes and all other information that was covered in class from a colleague you trust.* The instructor will NOT provide you with notes or PowerPoint presentations when you miss a class.

CELL PHONE POLICY: A major concern I have involves the use of cell phones and personal electronic devices. The classroom is NOT the place to make and receive personal phone calls or text messages. These distractive activities are extremely disrespectful to the instructor and other students. Cell phones and other personal electronic devices should not be used during class and students should turn them OFF upon entering the classroom. Emergency exceptions should be approved by the instructor prior to the beginning of class. **ANY STUDENT WHO IS OBSERVED TEXT MESSAGING OR OTHERWISE USING AN ELECTRONIC DEVICE (except for recording purposes) DURING CLASS WILL BE DROPPED FROM THE CLASS with an F.**

Withdrawals: Any student withdrawing from all classes on the Levelland Campus must report in person to the Advising Center in the Student Services Building for a withdrawal form. Instructions for obtaining a clearance from some departments of the college will be given at this time. Students who wish to drop a course or withdraw from classes at the SPC Reese Center must report, in person, to the Advising Center at the SPC Reese Center building 8 for a withdrawal form. Students at the Lubbock Centers should contact the advisor at the center for the withdrawal form. Students at the Plainview Extension Center must contact the Counseling Office in person for a withdrawal form.

Drops: A student who stops logging into a class or does not complete the assigned coursework should go through the procedure for dropping a course; otherwise they may be administratively withdrawn for lack of completion of coursework and their record will show an "X" or "F" instead of a "W." Failure to follow college policy by withdrawing according to this procedure will be reflected on a student's transcript by the presence of "X" or "F" marks, as determined by the instructor. It is the student's responsibility to verify administrative drops for incomplete coursework through his or her student online account. A grade of "W" will be given for student-initiated drops or withdrawals that occur prior to and through "The Last Day to Drop" as indicated in the academic calendar.

A student who quits logging in or submitting coursework and is administratively withdrawn from class will receive a grade of "X" or "F" as determined by the instructor through "The Last Day to Drop" as indicated in the online academic calendar.

Dropping the course:

- The form is not available before the **[Official Census Date](#)** or after the last day to drop.
- Get the instructor's (or an advisor's) signature for each course to be dropped.
- Return completed form to the Admissions and Records Office with \$5 drop fee. You must have a picture ID to complete the drop.
- A student CANNOT add, drop, or switch courses through Texan Connect after the semester's registration period is over.

No one but you can initiate the drop and it must conform to the procedure for dropping a course. Failure to finalize the drop procedure will result in an F grade on your transcript. The drop cannot be made retroactive. The drop date can be found on the SPC calendar.

Exams:

(a) We will have three exams (counting the final). Exams will consist of multiple choice questions, plus identifications (an identification is a grammatically correct answer that includes the who, what, where, when, why, what happened, and why the topic is important in US History). An example of an identification is available in Blackboard. Each exam will be worth 100 points.

(b) No student will be allowed to leave and then return to the classroom during an exam or quiz.

(c) If a student must miss an exam, a makeup exam is available. However, **only one exam can be made up per semester.** Makeup exams will be given on the day of the final exam. Makeup exams will be over the original content but will be ALL identifications. **The instructor is NOT responsible for reminding students to take a makeup exam, nor will she offer reviews or reminders of what to study. Failure to arrange to take a makeup exam will result in a grade of zero for that exam.**

(d) **You will not be allowed to take an early final because you have made other plans.**

(e) There are no exemptions for the final. If you do not take the final exam you will make an F in the course.

(f) There will be no makeup for the final exam.

(g) **All grades will be posted (as soon as possible) to Blackboard.**

(h) **South Plains College requires all students to become proficient in "academic English," a form of English that is typically used in academic, professional, and business contexts. While slang, regional idioms, and informal kinds of self-expression are appropriate in some contexts, they are out of place in academic writing. Writing instructors and professors in courses across the campus expect all students to demonstrate proficiency in using the conventions of academic English in their written work, whether it is in-class exams or take-home essays.**

Reading Quizzes:

(a) You will have ten multiple choice quizzes over various topics in *Texas Voices* and/or readings that will be provided to you.

(b) The reading quizzes will be taken through Blackboard.

(c) The quizzes will be timed.

(d) Quizzes can NOT be made up.

(e) **Your lowest two reading quiz grades will be dropped.**

(f) The remaining quizzes added together will be worth a total of up to 150 points.

(g) All grades will be posted in Blackboard.

(h) **You will have two attempts on each quiz. Your highest grade will count.**

Please note: You have more than one attempt on every quiz. You may use all the attempts for whatever reason—technological problems, low grades, whatever. I allow more than one attempt so that if you have a technological problem you will have another chance to complete the quiz. If you have computer or internet problems on the first attempt, check with IT at 806-716-2180 or blackboard@southplainscollege.edu before beginning the next attempt. Please keep in mind that IT help is NOT available 24/7. If you do have problems, you might want to consider using a different computer or internet connection on the second attempt. **The only**

way I will reset an attempt on ANY assignment or assessment is if there is a problem with Blackboard that is documented by the SPC IT department. PLEASE DO NOT ASK ME TO RESET QUIZZES!

If there is a problem with Blackboard or the SPC server I will be notified. When Blackboard becomes available again I will reset quiz due dates so that you can take quizzes affected by the outage.

Grade Book:

I have the Blackboard Grade Book (My Grades) set up so that it keeps a running total of your grades AFTER the lowest quizzes have been dropped.

The first column in the gradebook is your overall grade (after all the dropped quizzes have been dropped). It is the total of

column 2—Exam 1 (100 points)

column 3—Exam 2 (100 points)

column 4—Final Exam (100 points)

column 5---reading quizzes (with the lowest quizzes dropped, up to 150 points)
for a total of up to 450 points.

You won't see a grade in the Read-Total column until you take the third reading quiz (and have two to drop).

Every time you submit a reading quiz, Blackboard will recalculate your grades to determine your lowest quiz grades and drop them. The lowest grades will change depending on your grades.

You may experience a little glitch in Blackboard. Every assignment is due at 11:59 PM. Sometimes when a student submits a quiz at 11:59 PM, the program will mark it as late and flag it. I always check quizzes that are flagged. If your assignment is time-stamped 11:59, you will get credit. If it is time-stamped 12:00 you won't get credit.

Cheating

Plagiarism
