- Course Description: This course is a survey of fundamental principles of political science, including the American system of government and the origins and development of the constitutions of the United States. This course satisfies the Legislative requirements for teacher certification.
- Course Purpose: Government 2305, as taught at South Plains College, is a reading intensive course designed to acquaint the learner with the origin and development of the US Constitution, structure and powers of the national government including the legislative, executive, and judicial branches, federalism, political participation, the national election process, public policy, civil liberties and civil rights. This course meets the statutory requirements as set forth by the State of Texas.

Covid-19: This class is planned as a full-semester, face-to-face course. With some luck and appropriate actions (face covering use, hand-washing/sanitizing, social distancing, classroom cleanliness, etc.), we will complete this course as planned. However, we must also prepare for the possibility of a minor or significant disruption in our plans. If such were to occur, the instructor will contact, and keep informed, students via Blackboard of any necessary changes to complete course objectives. For example, if we as a class, or you as an individual, cannot take the Midterm Exam, additional chapter quizzes and essays covering the appropriate materials will be assigned in place of the classroom-based Midterm Exam. Flexibility is key, but course objectives will be completed and course credit will be earned.

<u>Purpose</u>: The objective of this course is to acquaint the undergraduate student with the functions, structure, organization, and institutions of the American Federal Government. This course will be structured toward providing the student information, which will enable him/her to be an intelligent, passionate, and active participant in the political realm. It has been said that the

health of the political system depends on just such participation, and an underlying aim of this course is to encourage it. *The instructor's primary purpose is to demonstrate the importance and relevance of government and politics in our daily lives*. Further GOVT 2305 meets statutory requirements as set forth by the state of Texas.

<u>**Course Requirements</u>**: It is assumed that the student will attend all lectures and take notes. Should the student miss a lecture, it is the responsibility of that student to obtain the class notes from a fellow student. The requirements for this course are extensive, but should not be excessively difficult if granted appropriate attention. A breakdown of requirements, their relative value towards the final grade, and example grades are as follows:</u>

Note Quizzes may or may not be announced in advance, are comprehensive, and shall consist of True/False and Fill-in style questions. Chapter quizzes will cover a single chapter, will be taken by the student outside of class time via Blackboard, and will consist of multiple-choice questions. The Midterm and Final Exams will consist of True/False, Fill-in, and essay style questions.

<u>Grades</u>: The grading scale for this course is as follows:

There is <u>no</u> curve for this course, nor for any assignment. You will be graded only by your own efforts. Rounding up of final grades will automatically occur for a maximum of one (1) point. The instructor reserves the right to round up grades in excess of one (1) point for those students who have demonstrated perfect class attendance, effort, improvement, and especially class participation.

<u>Missed Quizzes</u>: There are NO make-ups for missed quizzes. If a student misses a quiz for any reason, the next quiz of that type (Note or Reading) will count twice. If the last quiz of that type is missed, it will be graded as a ZERO.

<u>Missed Exams</u>: If a student should miss the Midterm or Final Exam for any reason, an All-Essay Make-up Exam will be provided at a mutually-acceptable date and time. Failure to complete this will result in a grade of zero (0).

Extra Credit: Periodically, and without prior notification, extra credit quizzes will take place. These will typically be for five (5) points, will cover class notes, and the points will be assigned on a class-by-class basis to various course assignments. If an Extra Credit Quiz is missed, it can NOT be made up. No other extra credit is available in this course.

<u>Attendance</u>: Clearly, this is a very odd and hopefully unique semester. Thus, attendance will not be taken daily. However, if a student has not participated in any form for three weeks, and has made no effort to communicate with the instructor, that student will be removed from this course.

<u>Promptness for Exams</u>: In order to ensure the integrity and security of the examinations, no student may begin the Midterm or Final Exam once any other student has completed the exam and exited the classroom.

Dishonesty: Cheating and/or plagiarism will **<u>not</u>** be tolerated! This will result in immediate failure of the course. Violators may be removed from South Plains College. Assisting another to cheat will also result in failure.

Electronic Devices: The use of cell/smart phones or laptops during course time will *not* be allowed in this class. These devices have proven excessively distracting in the classroom environment. The use of such devices will only be allowed if prior approval by the institution and instructor has been granted for special circumstances.

Students who fail to take a quiz during the availability period will receive a grade of zero (0) for that quiz.

Politics is based in large part on opinion, and it is a significant goal of this course to encourage the improved expression of one's opinion, as well as to increase one's understanding of the positions and opinions of others. Remember, our opinions are seldom right or wrong; they are simply our opinions. The instructor routinely employs anecdotal illustrations to explain and enhance course content. Such story-based examples are drawn freely from personal, familial, current event and student sources. The instructor strongly encourages all students to participate in class discussions; you and I will both get more out of this class. It is the instructor's hope that this class will be the one in which the student has the greatest opportunity to speak on a daily basis.

*There are, however, two significant exceptions to the Freedoms of Speech and Expression in this class: racist and/or sexist comments will **not** be tolerated (this includes comments concerning sexual orientation). The instructor expects that all students will respect one another's basic human rights.

*A pen will be required for all classroom quizzes and examinations. The use of pencil is unacceptable.
